ORDER NO. 4 MEMORIALIZING PREHEARING CONFERENCE

On Fanuary 5, 2010, a preheating conference was convened to consider (1) the motion for continuance filed by Double Diamond Utilities Company (Applicant) (3) the response in opposition filed by White Bluff Subdivision Ratepayers (Protestant) which raises issues concerning the effect, if any, of the final order recently issued in SOAH Docket No. 582-08-0698; TCEQ Docket No. 2007-1708-UCR and requests an escrow for potentially refundable utility payments, if the Applicant's motion for continuance is granted, and (3) a revised prehearing schedule if the motion for continuance is granted. Having considered these matters the Administrative Law Judge concludes that Applicant's motion for continuance should be granted, the request to establish an escrow should be denied, and the revised procedural schedule agreed to by the parties should be adopted

NOW, THEREFORE, IT IS ORDERED that the Applicant's motion for continuance is GRANTED and Protestant's request or an escrow is DENIED.

IT IS FURTHER ORDERED that the following schedule shall apply to this proceeding
