





On January 5, 2010, a prehearing conference was held. A procedural schedule has been developed with the input of the parties. That schedule is set out below and shall govern this case:

DATE	EVENT
January 18, 2010	Applicant to file initial supplemental discovery responses to all previous discovery.
March 1, 2010	Applicant to prefile its direct case in writing, including all testimony, exhibits, and proposed order of witnesses
March 15, 2010	Deadline for referral for mediation.
March 29, 2010	Protestants and OPIC to file their direct case in writing, including all testimony, exhibits, and proposed order of witnesses
April 29, 2010	Executive Director to file his direct case in writing, including all testimony, exhibits, and proposed order of witnesses.
<b>May</b> 7, 2010	Objections to prefiled testimony and exhibits, and end of deposition discovery, including depositions on written questions.
May 21, 2010	Responses to objections to prefiled testimony and exhibits
<b>May 26</b> , 2010	Prehearing conference.
June 2-4	Hearing on the merits.

The Parties can amend all dates herein by written agreement provided that any changes do not affect the dates scheduled for the hearing on the merits.



The Parties agree that if any of the dates set forth in this Agreed Scheduling Order fall on a Saturday, Sunday or legal holiday, the deadline will be the next business day that is not a Saturday, Sunday or legal holiday.
