ORDER NO. 9 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On December 8, 2014, Gulf Coast Waste Disposal Authority (GCA) filed with the Public Utility Commission of Texas (Commission) an application to amend its sewer Certificate of Convenience and Necessity (CCN) No. 20465 in Chambers County. On January 23, March 27, July 16, and August 18, 2015, GCA filed amendments to the application.

II. Commission Staff Recommendation on Administrative Completeness

On September 1, 2015, Commission Staff filed comments on the sufficiency of the amended application. Commission Staff finds that the amended application and notice is sufficient for further review. Consistent with Commission Staff's recommendation, the application, as amended, is deemed administratively complete.

III. Commission Staff Recommendation on Notice

Commission Staff recommended that GCA provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date.

Consistent with Staff's recommendation, GCA shall provide notice as described in Commission Staff's September 1, 2015 filing consistent with the criteria outlined in the attached memorandum of Jolie Mathis and Tracy Harbour of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum. GCA shall file affidavits evidencing proof of notice by the deadline set forth below.



IV. Procedural Schedule

The following procedural schedule as proposed by Commission Staff is adopted:

Deadline for GCA to provide the Commission with affidavits of notice (individual and published) a copy of the actual notice sent/published and the map included with the individual notice	October 1, 2015
Deadline for Interventions, filing of comments, or for Intervenors to request a hearing	30 days from provision of notice
Deadline for Commission Staff to file a recommendation and or procedural schedule with hard deadlines	November 8, 2015
