# BexarMet fires its 3 lobbyists

The board of the Bexar Metropolitan Water District fired the utility's three lobbyists in the Texas Legislature late Monday Express-News Staff Writer

as it reviewed a proposed new budget that for the first time in years doesn't include a rate increase. The reformist board — whose two newest members were elected early last month — has zeroed in on professional fees

as an easy target for cuts. It already has fired its 30-year general counsel and its longtime special counsel.

Its longtime general manager, Tom Moreno, is on two months of unpaid leave while the board looks into alleged financial irregularities

The three lobbyists — Charles "Chuck" Bailey, Mario Martinez and former 18-year legislator Ron Lewis — reportedly are The three lobbyists — Chanes Chuck balley, Mario Martinez and former 18-year legislator non Lewis — reportedly a paid a total of \$23,000 a month by the retail water agency, which serves about 80,000 customers in the Bexar County area. irregularities.

The three had given a report to the board but had left the meeting when the agenda item involving their firing came up.

Several of the seven board members seemed perturbed that the lobbyists couldn't point to specific things they were doing

for BexarMet in the current legislative session, which ends in about two months.

Board member John Longoria, himself a former legislator, spoke against the motion by board member Lesley Wenger.

"It would be a mistake of extreme magnitude, first, to declare them in breach of contract, and second, to cut them off and not have any representation at the Logislature." Longario sold. # BexarMet board fires its general manager

Tom Moreno's 20-year reign as general manager of the Bexar Metropolitan Water District ended Monday night when the San Antonio Express-News district's board voted to terminate the remaining five years of his employment contract for cause.

Moreno was making \$180,000 a year, potentially subjecting the district to a \$900,000 payout unless the contract was

The board voted 4-3 to end the contract and, again, by the same margin, to appoint Gil Olivares, chief financial officer and ended with good cause. acting general manager, as interim general manager.

Moreno's attorney, Thad Harkins, spent 45 minutes responding to a list of alleged deficiencies, oversights and wrongdoings laid out by the board in an April 6 notice of termination.

"Tom Moreno wants to resolve any issues he has with this board," Harkins said. "Tom Moreno wants to continue to

But without discussion, board member Lesley Wenger made a motion to terminate Moreno's contract for cause, and it serve." drew a quick second from Jose Gallegos Jr.

Moreno, a 35-year employee who oversaw the district as it grew from a sleepy rural water provider into a four-county behemoth that has been racking up debt while swallowing dozens of small companies, has been on unpaid leave for

Dissatisfaction with the district's tactics grew as water rates for its mostly poor customers increased rapidly while the almost two months. district filed lawsuits to grab more customers and water. Four new board members were elected to the seven-member board over a 15-month period ending in February.

Moreno was placed on leave Feb. 18 — his second suspension in three months — after a special audit found \$155,000 in questionable spending over the past two years. That included alleged salary overpayments of \$100,000 for 15 employees for 2003 and 2004, including almost \$30,000 for Moreno and \$13,550 for Sylvia Gámez, Moreno's now-fired former chief deputy.

Another special audit released earlier this month found alleged excess salary payments of almost \$60,000 to Moreno and \$21,143 to Gámez, from 1999 through 2002, for buyback of unused vacation time.

Other allegations against Moreno included entering into contracts without board approval, not giving employees annual evaluations, questionable handling of BexarMet property, continued payments to lobbyists whose contracts had been canceled and deferment of impact fees without board approval.

"I think that a majority of the board saw fit to move forward and to make BexarMet accountable and to make the leadership, the management of BexarMet, responsible for their actions or inactions, "Gallegos said after the meeting.

Harkins said the complaints about Moreno were dead issues dredged up for political reasons. He said Moreno had not made any missteps since the board gave him a good job evaluation and a year's extension on his contract in January.

"If you decide for political reasons, which are the reasons that we're seeing here, to get rid of Tom Moreno, at least have the common sense as public servants to honor the contract that's in place instead of trying to find some fiction to continu to injure my client," Harkins said.

In opposing the motion, board member John Longoria said Moreno had been given abbreviated due process.

"I do not agree with the procedures that have occurred," said Longoria, a former state legislator and Bexar County judge. "I do not agree with the conclusions that have been drawn."

Longoria was joined by Herman Sanchez and Ysidro Solis in voting against the motion.

## Editorial: BexarMet shake-up thoroughly justified

A big housecleaning is under way at the Bexar Metropolitan Water District.

The bright light of unobstructed public scrutiny is finally shining on the workings of the water utility under suspended General Manager Tom Moreno, and it's not a pretty picture.

A new study of BexarMet spending practices, conducted by the auditing firm of Garza Gonzalez and Associates, found shoddy records and \$155,000 in questionable spending during the previous two years.

The examination found almost \$60,000 in payments made to Moreno in excess of his approved salary from 1999 through 2002.

Former City Councilman Rick Vasquez was paid for three years of consulting work, but BexarMet has no records of any work product from Vasquez during that time, the study found.

Moreno's record appears indefensible, and the board, which has a majority of reform-minded members after the February election, has scheduled an April 18 hearing on whether to fire him.

The board must act cautiously to protect the agency from being required to buy out Moreno's contract, which was mysteriously extended a year by the previous board majority.

Meanwhile, the new board majority has dumped the agency's old lobbyists and hired two new firms. The three previous lobbyists were unable to tell the board what they were doing for the agency during the ongoing legislative session.

The new board also has severed ties with the agency's longtime general counsel, West and West.

Under the new board's proposed budget, expenses for professional fees of lawyers, lobbyists and engineers will be reduced from \$2.5 million to \$1 million. Ratepayers finally have something to be happy about.

While the changes may seem dramatic and disruptive to some, they are steps in the right direction. Under Moreno's management, BexarMet had become the most dysfunctional public entity in the county.

Reforms are needed to bring BexarMet into the 21st century as a transparent, professionally operated government agency. This is a cleanup effort that is long overdue.

## Water district says it intends to fire Moreno

After another supplementary audit questioned more costs, the board of the Bexar Metropolitan Water District voted late Monday to give suspended General Manager Tom Moreno a notice of termination for cause.

The board, acting under terms of Moreno's contract, issued the notice and set a Friday hearing to allow him to respond to allegations that have been building against him since a reformist board took power in February.

"As a responsibility to our ratepayers and customers, we have to make sure that any breach of fiduciary duty does not occur, and if it does occur, then we need to take corrective action," said Jose Gallegos Jr., who made the motion for notice of termination. "This is part of what we feel is regrettable but corrective action that needs to take place."

The board had placed Moreno on an unpaid 60-day suspension on Feb. 18 — his second suspension in just over three months — after an audit found \$155,000 in questionable spending at the utility over the past two years.

The board had directed the auditing firm of Garza Gonzalez and Associates to look at some more specific records in the interim and received that report Monday night before adjourning to an almost two-hour closed session.

The new audit reported excess salary payments of almost \$60,000 to Moreno and \$21,143 to his now-fired chief aide, Sylvia Gámez, from 1999 through 2002 for buyback of unused vacation time.

The certified public accountant, Rene Gonzalez, also reported that Gámez wrote checks to Moreno totaling \$10,173 in 2001 for alleged excess payroll deductions, but added that "we determined that \$5,212 of the \$10,173 paid to the general manager was never deducted from the general manager's salary."

Gonzalez also reported finding no evidence of any work product for more than three years of consulting work by former City Councilman Richard Vasquez. He was supposed to be putting in 40 hours a week on planning and grant acquisitions from October 1997 through November 2000 at a cost of more than \$131,000.

"With all of the evidence we were presented, it just became impossible to ignore the overwhelming record of mismanagement," said Lesley Wenger, who took office in February. "It's incumbent on the board to act."

The vote to give the notice of termination was 4-3 with President Victor Villarreal and Jim Clement joining Gallegos and Wenger.

Board member John Longoria, who led the opposition to the motion, was joined by Robert Sanchez and Ysidro Solis.

"If he's done wrong, I don't defend him, but for someone who's been here for 35 years, he should at least be given a chance to answer the allegations before he's given a notice of termination and publicly humiliated," Longoria said. "People should be given due process whether they're a maintenance worker or the general manager."

Moreno, who has a five-year employment contract after the board in January added a year to it, was making \$180,000, potentially subjecting the district to a \$900,000 payout unless the contract is ended with good cause. Moreno has served as the district's general manager for the past 20 years.

The previous special audit had found about \$100,000 in salary overpayments for 15 employees for 2003 and 2004, including almost \$30,000 for Moreno and \$13,550 for Gámez.

The two newest members of the reformist board had campaigned to clean up the operation, which has been plagued by overspending and years of double-digit rate increases for its 80,000 customers.
