INTERROGATORY NO. 15: Please explain why the Company did not file an amended water and/or sewer CCN application after April 1, 2002.

RESPONSE: The Company did not file for a CCN because there was not a need for service at the time that would have justified the application and the Company was not aware that its CCN did not include all of the South Ridge of Lindsay subdivision.
