I am writing on behalf of Lindsay Pure Water Company, CCN No. 12858 ("LPWC"). LPWC's service area is located adjacent to the area proposed for certification by the Town of Lindsay ("Lindsay"). LPWC provides water service to customers within its CCN area and intends to provide service to future customers within Lindsay proposed CCN area.

As a result of a previously contested CCN application filed by Lindsay, Lindsay and LPWC reached a service area settlement in 2002. WASHINGTON — The country's 48 million Social Security recipients are in line to get the biggest boost to their monthly benefit checks in more than a decade, though for many higher costs for energy and Medicare will eat up much of the gain.




