ORDER NO. 2 ADDRESSING SUFFICIENCY OF APPLICATION AND NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE

On December 12, 2014, Ganado Telephone Company, Inc. (Ganado) filed a true-up report in accordance with ordering paragraph 2 of the final Order in Docket No. 41846.¹

I. Staff Recommendation on Sufficiency of Application and Notice

On January 12, 2015, Commission Staff filed a response to Order No. 1 regarding sufficiency of the application and notice. Commission Staff determined that Ganado's application is sufficient and satisfies the requirements of P.U.C. PROC. R. 22.73 and P.U.C. SUBST. R. 26.406. Commission Staff recommends that no additional notice beyond *Texas Register* notice is required. Consistent with Commission Staff's recommendation, Ganado's application and notice are deemed sufficient.

II. Establishing Procedural Schedule.
