#### BACKGROUND

On December 15, 2014, Concho Valley Electric Cooperative, Inc. ("CVEC") filed an application for an electric service area exception within Coke County, Texas ("Application"). The proposed service area exception is in Coleman County Electric Cooperative, Inc.'s ("CCEC") singly certificated service area. Louis M. Klement, Jr. has requested electric service from CVEC because it has existing electric distribution facilities closer than CCEC. The proposed service area exception will not affect the existing certificated boundaries of CVEC and CCEC. Both CVEC and CCEC have agreed to the proposed service area exception.

Commission staff recommended in its sufficiency recommendation on December 29, 2014 that this application be treated as a "service area exception" because CVEC and CCEC agree to the change, the affected electric customer requested the change, the application is complete, and proper notice has been provided. P.U.C. PROC. R. 22.55 notes that in proceedings other than those governed by §§ 22.51- 22.53, of this title (relating to Notice), the presiding officer may require a party to provide reasonable notice to affected persons. Staff recommended that *Texas Register* notice be deemed reasonable and that no additional notice (beyond *Texas Register* notice) be required. Order No. 2 deemed CVEC's application and notice sufficient and stated that the application shall be considered a service area exception pursuant to P.U.C. SUBST. R. 25.101(b)(1)(B). No party has requested intervention in this proceeding.

#### PROJECT DESCRIPTION

Louis M. Klement, Jr. requested electric service from CVEC for a hunting cabin located at W 100°15'18.65" N 31°55'44.65", Coke County, Texas. CVEC has electric distribution facilities approximately 2,144 feet away from the requested service location.

CCEC would have to extend electric distribution facilities approximately 4,300 feet from their closest existing power line to serve Mr. Klement's requested service location. The proposed service area exception is not anticipated to have any negative effect on community values, recreational and park areas, environmental integrity, and historical and aesthetic values.

# NEED AND COST FOR THE PROPOSED CONSTRUCTION

CVEC has the nearest electric distribution facilities in the vicinity of Mr. Klement's requested service location. CCEC would need to construct approximately twice as much line as CVEC to serve Mr. Klement. CVEC has estimated that it can extend electric service to Mr. Klement's property at a cost of \$10,817.02. Mr. Klement will pay \$3,725.12 as aid-to-construction and have a raised minimum of \$86.74 to be paid over sixty (60) months. Mr. Klement requested service from CVEC because they are substantially closer to his property and would cost substantially less than CCEC.

## CONCLUSIONS AND RECOMMENDATIONS

Consistent with PURA § 37.056, Commission staff recommends approval of this application for a service area exception of CVEC, as shown on the maps attached to the application.
