ORDER NO. 5

CONCERNING MOTIONS TO DISMISS BY DENTON COUNTY FRESH WATER SUPPLY DISTRICT No. 10 AND MAHARD EGG FARM, INC.

On June 3, 2003, Denton County Fresh Water Supply District No. 10 (District) filed a motion to dismiss the remaining intervenors in this case, Mahard Egg Farm, Inc. and Prosper Independent School District (Prosper ISD). On June 26, 2003, Prosper ISD filed its opposition to District's motion to dismiss. On July 3, 2003, Mahard Egg Farm, Inc. (Mahard) filed a motion to dismiss District's application and its opposition to District's motion to dismiss.

A preliminary conference is already set in this case for **July 21, 2003, at 9:00 a.m.** to consider discovery disputes and other pending matters. The motions to dismiss will be considered at that time. **On or before July 17, 2003**, District shall respond to Mahard's motion to dismiss, Prosper ISD shall respond to Mahard's motion to dismiss, and the Executive Director shall respond to both motions. To the extent it is necessary to produce evidence at the July 21 preliminary conference, the burden will be on the proponent of a particular motion.
