ORDER NO. 14

CONCERNING REQUEST TO SUBMIT CERTIFIED QUESTIONS

On October 13, 2003, the Administrative Law Judge issued Order No. 13 stating he would wait to hear the progress of settlement negotiations between Denton County Water Supply District No. 10 (District) and Prosper Independent School District (PISD) before considering submitting certified questions on the standing of PISD and Mahard Egg Farm, Inc. (Mahard) to be parties in this case. On October 20, 2003, PISD reported that the District rejected its offer to settle.

The Administrative Law Judge (ALJ) has determined to submit certified questions on the standing of PISD and Mahard if all reasonable possibilities of settling the case have run their course. In view of the fact that the standing issue could decide the entire controversy in this case, the ALJ believes the matter should be submitted to the Commission before going through a long hearing process.

A preliminary conference is set for **October 28, 2003, at 1:30 p.m.** at the State Office of Administrative Hearings (SOAH), 4th Floor, William P. Clements Building, 300 West 15th Street, Austin, Texas to consider the following:

- Whether there is any remaining likelihood of settling the case.
- If not, the ALJ wants to discuss framing the issues and agreed facts. Obviously, the ALJ will have the final say on submitting the certified questions.

In its response to Order No. 12, the District said it has purchased without condemnation the public utility easement across Mahard's property that will be used to interconnect the service area with the District's wholesale service provider. The ALJ wants to discuss this matter with the District and Mahard.
