

Prosper Independent School District ("PISD") hereby provides notice that it is requesting to withdraw as a party to this proceeding. PISD attempted to negotiate with Huffines, the developer associated with this application. However, Huffines has refused to negotiate in good faith with PISD.

PISD is currently negotiating with Denton ISD and its attorney, Randolph Stout, concerning detachment of the proposed area. PISD has decided that it would be more prudent to focus on this approach, as Huffines has demonstrated it has no regard for Prosper schools and/or the Prosper community. Therefore, PISD requests to withdraw from this proceeding.
