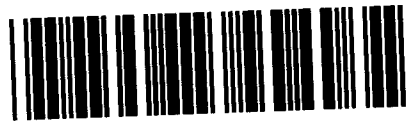


REMANDING CASE AND ORDER OF DISMISSAL
