ADDENDUM TO DETAILED ANALYSIS JUSTIFYING NON-ACCEPTANCE OF SERVICE FROM TRINITY RURAL WATER SUPPLY CORP.

Winn Professional Engineers and Constructors, LLC has performed a subsequent analysis for Trinity Rural Water Supply Corporation to serve the Eagle Falls development. The results of this subsequent analysis, dated September 15, 2009, and sent to us under a cover letter dated October 7, 2009, is attached hereto.

The new analysis indicates a cost to Eagle Falls Water Supply, LLC of \$2,609,400 with an additional \$875/lot parity fee due up front. The new cost estimate still exceeds the cost estimate for Eagle Falls Water Supply, LLC to construct their own system by \$1,783,333. Receiving water service from Trinity Rural Water Supply Corporation would cost Eagle Falls Water Supply, LLC over three times what they would spend themselves, making this still making this option not economically viable.
