On October 28, 2009, Sonterra MUD filed applications with the Texas Commission on Environmental Quality (TCEQ or Commission) to have dual certification with portions of CCN Nos. 10002 and 20908 from Jarrell Schwertner WSC and to obtain a water and sewer CCN in Williamson County. The applications were accepted for filing on December 28, 2009. On January 27, 2010, Sonterra MUD filed a request for a 45 day extension to provide required notices. On January 28, 2010, an extension until April 5, 2010, was granted.

On April 6, 2010, the Commission received a letter via email requesting withdrawal of these applications
