## ORDER NO. 6 DENYING REQUESTS FOR PARTY STATUS

On May 2, 2006, Allan and Lisa Newsom submitted a specific request for independent party status in the captioned proceeding. The Applicant (Tapatio Springs Service Co., Inc.) has opposed that request. In the view of the Administrative Law Judge ("ALJ"), at this stage in the case, the entry of additional parties is inappropriate, absent a showing that such persons have a compelling reason for failing to obtain party status earlier. The Newsoms have not presented such a reason In addition, the group of aligned parties represented by Elizabeth Martin appears to be vigorously representing the interests of ratepayers in this case. If the Newsoms wish to influence this proceeding, they have the realistic option of sceking to assist that aligned group in the presentation or financing of its case. Accordingly, the ALJ concludes that the Newsom's request for party status should be denied.
