CITY OF AUTIN'S MOTION TO STAY DISCOVERY

COMES NOW, the City of Austin ("City") and files this Motion to Stay Discovery for the reasons stated herein.

I. GOOD CAUSE FOR STAY

The City requests that an order be issued to stay discovery until there is a ruling on the City's pending motion to dismiss for lack of jurisdiction. On February 23, 2014, the City filed a motion to dismiss pursuant to P.U.C. Proc. R. 22.181 for lack of jurisdiction. Because there is a question of whether there is jurisdiction to consider the pending rate appeal there is good cause to grant the requested stay.

The Petitioners filed a Response to the City of Austin's Motion to Dismiss for Lack of Jurisdiction on March 2, 2014. The City will be filing a Reply to Petitioner's Response to City's Motion to Dismiss for Lack of Jurisdiction per the Public Utility Commission's rules. The City anticipates that a ruling on the City's Motion in the near future. Should a court determine jurisdiction in favor of the Petitioners, the Parties can submit a Proposed Procedural Schedule. The stay is not requested for the purpose of delay, but in the interest of justice and judicial economy.



II. PRAYER

The City respectfully requests that the City's Motion to Stay Discovery be granted pending a ruling on the City's Motion to Dismiss for Lack of Jurisdiction.
