## CITY OF AUTIN'S MOTION TO STAY DISCOVERY

COMES NOW, the City of Austin ("City") and files this Motion to Stay Discovery for the reasons stated herein.

## I. GOOD CAUSE FOR STAY

The City requests that an order be issued to stay discovery until there is a ruling on the City's pending motion to dismiss for lack of jurisdiction. On February 23, 2015, the City filed a motion to dismiss pursuant to P.U.C. Proc. R. 22.181 for lack of jurisdiction. Because there is a question of whether there is jurisdiction to consider the pending rate appeal there is good cause to grant the requested stay.

The Petitioners filed a Response to the City of Austin's Motion to Dismiss for Lack of Jurisdiction on March 2, 2015. The City will be filing a Reply to Petitioner's Response to City's Motion to Dismiss for Lack of Jurisdiction per the Public Utility Commission's rules. The City anticipates that a ruling on the City's Motion will be made in the near future. Should a court determine jurisdiction in favor of the Petitioners, the Parties can submit a Proposed Procedural Schedule. The stay is not requested for the purpose of delay, but in the interest of justice and judicial economy.



### II. PRAYER

The City respectfully requests that the City's Motion to Stay Discovery be granted pending a ruling on the City's Motion to Dismiss for Lack of Jurisdiction.
