SOAH ORDER NO. 7 DENYING MOTION FOR RECONSIDERATION; ADOPTING PROCEDURAL SCHEDULE; AND NOTICE OF HEARING

On May 18, 2015, the City of Austin (City) filed an appeal with the Public Utility Commission of Texas (Commission) of Order No. 6, which ruled on jurisdiction. The City also moved for reconsideration of Order No. 6. The request for reconsideration is denied. The City had ample opportunity to provide evidence and argument concerning jurisdiction, and the City's appeal is now pending before the Commission.

At the prehearing that convened on May 4, 2015, in the above-styled matter, the parties agreed to the following procedural schedule, which is adopted and shall govern the proceedings in this matter.
