#### COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION

§

RIGHTS IN HENDERSON COUNTY

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files its Supplemental Recommendation. In support of its Supplemental Recommendation, Staff states the following:

#### I. Background

On December 22, 2014, Aqua Texas, Inc. (Aqua Texas) and Union Hill Water Supply Corporation filed their application regarding the sale and transfer of certain water assets and corresponding certificate of convenience and necessity. Aqua Texas, as the purchaser, requested the approval of the sale and transfer of Union Hill Water Supply Corporation's water assets and corresponding water certificate of convenience and necessity (water CCN No. 11439) for Union Hill Water Supply Corporation's service area in Henderson County, Texas.

On February 23, 2015, Staff filed its Comments regarding Aqua Texas and Union Hill Water Supply Corporation's application. Staff recommended that the Commission deem Aqua Texas and Union Hill Water Supply Corporation's application not administratively complete due to certain deficiencies. Specifically, Staff identified deficiencies regarding mapping and the list of certain entities that are within two (2) miles of the proposed service area. Staff recommended that Aqua Texas be permitted to cure these identified deficiencies.

On February 24, 2015, the Administrative Law Judge entered Order No. 3. Order No. 3 found that Aqua Texas and Union Hill Water Supply Corporation's application was deficient and not administratively complete. Additionally, Order No. 3 permitted Aqua Texas to cure deficiencies identified by Staff by March 26, 2014 and required Staff to file a supplemental recommendation in response to Aqua Texas' cured deficiencies by April 23, 2015. Staff's Supplemental Recommendation is timely filed.

On March 25, 2015, Aqua Texas filed additional documents in response to Order No. 3.

#### II. Applicable Statutes and Rules

### A. Sale Transactions and Transfers of a Certificate of Convenience and Necessity

The Texas Water Code details the requirements for the sale of a water system. The relevant portions of the Texas Water Code state:

- (a) A utility or a water supply or sewer service corporation, on or before the 120th day before the effective date of a sale, acquisition, lease, or rental of a water or sewer system that is required by law to possess a certificate of public convenience and necessity or the effective date of a merger or consolidation with such a utility or water supply or sewer service corporation, shall:
  - (1) file a written application with the utility commission; and
  - (2) unless public notice is waived by the utility commission for good cause shown, give public notice of the action.
- (b) The utility commission may require that the person purchasing or acquiring the water or sewer system demonstrate adequate financial, managerial, and technical capability for providing continuous and adequate service to the requested area and any areas currently certificated to the person.<sup>1</sup>

The Commission's substantive rules detail similar requirements for the sale of a water system.<sup>2</sup> The purchaser of the water system "must demonstrate adequate financial, managerial, and technical capability for providing continuous and adequate service to the requested area and any areas currently certificated to the person." With regards to the sale and transfer of a certificate of convenience and necessity (CCN), the Texas Water Code states that a CCN may not be sold "unless the utility commission has determined that the purchaser . . . is capable of rendering adequate and continuous service to every consumer within the certificated area, after considering the factors under Section 13.246(c)."

With regards to the processing of an application for the sale and transfer of assets, the Commission's substantive rules state:

On or before the 120th day before the effective date of any sale, acquisition, lease, rental, merger or consolidation of any water or sewer system required by law to possess a certificate of public convenience and necessity, the utility or water supply or sewer service corporation shall file a written application with the commission and give public notice of the action.<sup>5</sup>

The 120-day period begins on the later of: (1) the filing of a sale, transfer, merger application; (2) if mailed notice is required, the date that the applicant mailed notice; or (3) if newspaper notice is required, the last date of publication of the notice.<sup>6</sup>

#### B. Notice

An applicant requesting approval of the sale and transfer of assets and accompanying CCN must send notice "on the form required by the commission . . ." The Commission's form requires notice to be sent to current customers, neighboring systems, and municipalities. With respect to the transfer of a CCN, notice must be sent to "cities and neighboring retail public utilities providing the same utility service whose corporate limits or certificated service area boundaries are within two miles of the requested service area boundaries, and any city with an extraterritorial jurisdiction which overlaps the proposed service area boundaries." Additionally, the Commission may require notice to be published once each week for two consecutive weeks in a newspaper of general circulation in the area in which the retail public utility being transferred is located . . . ."

#### C. Administrative Completeness

An application is not considered filed with the Commission until "a determination of administrative completeness is made." "If the commission determines that material

deficiencies exist in any pleadings, statement of intent, applications, or other requests for commission action addressed by this chapter, the notice or application may be rejected and the effective date suspended until the deficiencies are corrected."

#### III. Supplemental Recommendation and Proposed Procedural Schedule

Staff has reviewed Aqua Texas and Union Hill Water Supply Corporation's application and accompanying documents and the additional documents submitted by Aqua Texas on March 25, 2015. Based on this review, Staff recommends that Aqua Texas and Union Hill Water Supply Corporation's application be found administratively complete. Staff's recommendation is based on the attached memorandum of Elisabeth English, Engineering Specialist in the Water Utilities Division.

With regards to notice, Staff recommends that Aqua Texas and Union Hill Water Supply Corporation be required to send notice to the following: (1) any districts, groundwater conservation districts, counties, utilities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service area and (2) any city with an extraterritorial jurisdiction which overlaps the proposed service area. The entities that should receive notice are: (1) the entities listed in Aqua Texas and Union Hill Water Corporation's application; (2) the entities listed on the revised list submitted by Aqua Texas on March 25, 2015; (3) and Moore Station Water Supply Corporation. Additionally, Staff recommends that Aqua Texas and Union Hill Water Supply Corporation publish notice of its application once each week for two (2) consecutive weeks in a newspaper of general circulation in Henderson County, Texas. Staff recommends that the form notices and affidavits attached to Ms. English's memorandum be used by Aqua Texas and Union Hill Water Supply Corporation.

To assist in the processing of Aqua Texas and Union Hill Water Supply Corporation's application, Staff requests that the Commission adopt the following procedural schedule:

Event	Deadline
Affidavits evidencing provision and publication of notice	May 7, 2015
Deadline for Staff to file a supplemental procedural schedule	May 21, 2015
Intervention deadline, and deadline for intervenors to file comments or request a hearing	30 days after the mailing or publication of notice, whichever occurs later

#### IV. Conclusion

Staff recommends that: (1) Aqua Texas and Union Hill Water Supply Corporation's application be found administratively complete; (2) Aqua Texas and Union Hill Water Supply Corporation used the form notices attached to this Supplemental Recommendation in providing and publishing notice; and (3) the Commission adopt the above-mentioned procedural schedule.

On December 22, 2014, Aqua Texas, Inc. (Aqua) filed an application with the Public Utility Commission (Commission) to purchase water system assets and transfer the service area under Union Hill Water Supply Corporation's (Union Hill) Certificate of Convenience and Necessity, CCN No. 11439, in Henderson County, Texas. Union Hill's CCN No. 11439 will be canceled as a result of this application. The application is being reviewed under the P.U.C. Subst. R. 24.109.

The notice requirements for the proposed STM of CCN's are listed in P.U.C. SUBST. R. 24.112(c) which states that notice shall be provided to current customers, as well as other affected parties as determined by the Commission. The intent Aqua's STM application is to amend their current CCN, and therefore Commission staff has determined that it is appropriate that the notice requirements for CCN amendments also be met (P.U.C. SUBST. R. 24.106(b)(2)) which states "Applicants are also required to provide notice to the county judge of each county and to each groundwater conservation district that is wholly or partly included in the area proposed to be certified".

Therefore it is Staffs position that notice should be required for all entities as stated in original application and the revised list submitted on March 25, 2015 - as well as Moore Station WSC (11127) which was identified during the mapping review. Additionally, Staff suggests that publication of notice also be requested per CCN amendment notice requirements.

Based on staff's review of the information in the application, staff recommends that the application be deemed sufficient for filing. Staff has amended the notice documents to meet Commission requirements, which are attached to this memo. Staff further recommends the following:

- 1) The Applicant provide the attached notice of the application to the following:
  - a) any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service area;
  - b) any city with an extraterritorial jurisdiction which overlaps the proposed service area;

- published notice to the public which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Henderson County;
- In addition to those systems identified in the application and supplemental list thereafter, the applicant will also need to send notice with a copy of the proposed CCN map to: <u>Moore Station WSC (11127)</u>
- 3) Applicant shall include copy of a map showing the proposed service area with the individual notices to neighboring utilities, other affected parties and each landowner. It is the Applicant's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ's web site located at <a href="http://www14.tceq.texas.qov/iwud/">http://www14.tceq.texas.qov/iwud/</a>.
- 4) Applicant provide a copy of the actual individual notice sent with attached signed and notarized affidavit that the notice was given. For newspaper notice, the Applicant should provide a tear sheet of the actual newspaper publication for each week along with a publisher's affidavit as proof that sufficient notice was provided.
