



DEFINITIONS

- 1) "You" refers to the City of Three Rivers and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- Staff 3-1 Please provide documentation demonstrating that compliance can be achieved with the Texas Commission on Environmental Quality ("TCEQ") enforcement action concerning failure to initiate maintenance and housekeeping practices to ensure the good working condition of the automatic valve controlling the supplemental backwash, outstanding since August 12, 2011. Such documentation should include the following:
- a) A compliance plan, including both the "rule exception request" submitted to TCEQ and the City's plan to replace the valve in question if necessary, and
 - b) Estimates of associated costs and the source of funding to pay those costs.
