

A preliminary hearing was held in this case on October 11, 2012. The Executive Director (ED) of the Texas Commission on Environmental Quality (TCEQ) appeared through attorney Hollis Henley. The Office of Public Interest Counsel (OPIC) appeared through attorney Garrett Arthur. Shalako Estates and Canyon Springs Water Systems (Applicant) appeared through attorneys Georgia Crump and David Klein. Fred B. Jeffries Jr. appeared on his own behalf.

Jurisdiction

Exhibits ED-A, ED-B, and ED-C relevant to jurisdiction were admitted into evidence for jurisdictional purposes only, and the Administrative Law Judge (ALJ) took official notice that jurisdiction was established.

Party Status

The ED, OPIC, the Applicant, and Mr. Jeffries were admitted as parties to this proceeding.

Dismissed and Remanded

Near the conclusion of the preliminary hearing, the parties announced that they had settled this matter. The Applicant moved, without objection, for this case to be remanded to the


