



Dear Mr. Smith:

Your surcharge request for Canyon Springs Water Works, PWS No. 1330006, received on June 21, 2013, for LCRA lab testing fees amounting to \$2,564.00 was accepted for filing by the Texas Commission on Environmental Quality on July 16, 2013. Pursuant to 30 TAC 291.21(k)(2) of the Commission's Rules, a \$0.94 per customer per month surcharge is approved for a fourteen (14) month period for Canyon Springs Water Works, PWS No. 1330006. The utility cannot charge this surcharge for more than fourteen (14) months and should cease charging the surcharge if the outlay for the charges, \$2,564.00, is recouped in a shorter period due to increases in customer connections.

Please attach this letter to your approved tariff as authorization to charge the surcharge.

Pursuant to 30 TAC 291.21(k)(2) of the Commission's Rules, the first bill sent out that includes this surcharge should include a short statement such as the following:

"The sampling surcharge has been approved by the TCEQ to cover fees incurred by the utility and is required by the Safe Drinking Water Act."

On December 28, 2011, the application referenced above was received from W.E. Vlasek dba Shalako Estates and Canyon Springs Water Systems (Shalako). The application was assigned Application No. 37233-R, and the purpose was to increase retail water rates to customers in Kerr County, Texas. Per TCEQ letter dated February 3, 2012, a revised notice of the rate change was provided to the customers by the applicant on or about February 8, 2012. The Commission received requests for a public hearing on the application from more than 10% of the customers.

The Honorable Hunter Burkhalter, an administrative law judge (ALJ) of the State Office of Administrative Hearings (SOAH), conducted a preliminary hearing on October 11, 2012, in Austin, Texas, and designated the following parties: the Applicant, represented by Georgia Crump, Attorney; the Executive Director (ED) of the TCEQ, represented by Hollis Henley; the Office of Public Interest Counsel (OPIC) of the TCEQ, represented by Garrett Arthur, and Ratepayer Fred B. Jeffries Jr.

The parties entered into egotiations and reached a settlement in the matter. On October 18, 2012, the matter was dismissed from SOAH's docket by the ALJ in Order No. 1, and remanded to the ED for uncontested processing.


