We are pleased to announce that Laguna Vista, Ltd, of 112 No. Crockett Street, Granbury, TX 76048 has submitted an application with the Public Utility Commission of Texas to sell facilities and transfer water and sewer, CCN Numbers 11938 (water) and 20766 (sewer) in Hood County to Laguna Tres, Inc., P.O. Box 2337, Granbury, TX 76048.

The sale is scheduled to take place as approved by the Commission (V.T.C.A. Water Code Section 13.301). The transaction and the transfer of the CCN include the subdivision of Laguna Vista.

The area subject to this transaction is located approximately 4 miles North of downtown Granbury, Texas and is *generally* bounded on the north by the intersection of Killough and Weatherford Highway; on the east by FM 51; on the south by the intersection of FM 51 and Reed Rd, and on the west by Lake Granbury.

The total area being requested includes approximately 159 acres for water and 6 acres for sewer and serves 205 water customers and 8 sewer customers. This transaction will have no effect on the current customer's rates and services.

Affected persons may file written protests and/or request a public hearing within 30 days of this notice. To request a hearing, you must:

- 1. state your name, mailing address and daytime telephone number.
- 2. state the applicant's name, application number or another recognizable reference to this application.
- 3. include the statement "I/We request a public hearing".
- 4. write a brief description of how you, the persons your represent, or the public interest would be adversely affected the by proposed transaction and transfer of the CCN, and
- 5. state your proposed adjustment to the application of CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

Only those person who submit a written request to be notified of a hearing will receive notice if a hearing is scheduled. The Commission will issue the CCN requested in the reference application unless a hearing is scheduled to consider the transaction. If no protests or requests for hearing are filed during the comment period, the Commission may issue the CCN 30 days after publication of this notice.
