**ORDER NO. 3
FINDING APPLICATION SUFFICIENT AND COMPLETE;
FINDING PROPOSED NOTICE SUFFICIENT AND REQUIRING NOTICE; AND
ESTABLISHING PROCEDURAL SCHEDULE**

On April 1, 2015, Public Utility Commission of Texas (Commission) Staff recommended that the above-styled and numbered application, in combination with the supplemental filing, be found sufficient and complete and that the proposed notice be found sufficient. In addition, Commission Staff recommended that Laguna Tres Inc. (Laguna Tres) be allowed to proceed with the proposed transaction, noted that a public hearing is not necessary, and that Laguna Vista, Ltd.'s (Laguna Vista's) Certificate of Convenience and Necessity (CCN) Nos. 11983 and 20766 remain in the name of Laguna Vista until the transfer is complete and approved pursuant to Commission rules.

Consistent with Commission Staff's recommendation (1) the application, in combination with the supplemental filing, is sufficient and complete; (2) the proposed notice is sufficient and Laguna Tres may proceed to provide notice by publication and to current customers, neighboring systems, and cities consistent with Commission Staff's recommendation; (3) Laguna Tres can proceed with the proposed transaction; and (4) Laguna Vista's CCNs should remain in the name of Laguna Vista until the transfer is complete and the application is approved by the Commission.

Commission Staff also proposed a procedural schedule for continued processing of this docket. Accordingly, the following procedural schedule shall apply:

Deadline for affidavits evidencing proof of notice	April 30, 2015
Deadline to Intervene	30 days after mailing or publication of notice, whichever occurs later

Deadline for Commission Staff's recommendation or request for a hearing on the merits	June 10, 2015
Deadline for Applicants to request a hearing and file responses, if any, to intervenor comments, and Commission Staff's recommendation	June 17, 2015
120-day deadline for Commission approval and to allow Laguna Tres and Laguna Vista to move forward with the transaction	120 days from the date this Order is signed
Expiration of the Commission's approval of the sale	One year from the Commission's Order approving the transaction

Parties are reminded that original and 10 copies of documents relating to this proceeding must be filed with the Commission filing clerk according to P.U.C. PROC. R. 22.71. A copy of each document filed with the Commission must also be served on all parties.

Parties are also reminded that direct communications with the administrative law judges and presiding officer (collectively, ALJs) are prohibited. Questions concerning this Order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
