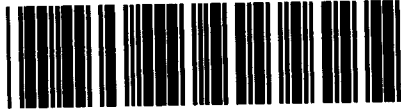



MEDIATOR'S FINAL REPORT

On March 2, 2011, the mediation reconvened and the parties reached an agreement in principle. The mediation remained in recess pending notification that the settlement was approved by both parties and that the City of Jarrell had withdrawn its pending application and requested the case be dismissed. The City of Jarrell subsequently withdrew its application and, pursuant to its request, the case pending at the State Office of Administrative Hearings was dismissed. There being no further reason to keep this mediation open, the mediation is concluded.
