
**ORDER NO. 2  
AMENDING PREHEARING SCHEDULE**

On November 22, 2010, the parties collectively filed a joint status report and request to amend the schedule. In part, because the case has been referred to mediation, the Administrative Law Judge (ALJ) did not receive the filing until December 9, 2010. The motion for an amended procedural schedule is GRANTED. The following schedule now applies:

If a settlement is not reached, the hearing on the merits of the application will be held at 10:00 a.m., on July 12, 2011, at the SOAH hearing facility in the William P. Clements Building, 4<sup>th</sup> Floor, 300 West 15<sup>th</sup> Street, Austin, Texas. The parties estimate the hearing may last two days. Because the hearing will last two days, Applicant should secure a court reporter.
