JOINT STATUS REPORT AND REQUEST FOR AMENDED PROCEDURAL SCHEDULE

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

The City of Jarrell, Texas, Jarrell Schwertner Water Supply Corporation. Troy Bradshaw, and the Executive Director of Texas Commission on Environmental Quality (collectively "the Parties") file this Joint Status Report and Request for Amended Procedural Schedule and would respectfully show the following:

- The Parties participated in mediation on November 17, 2010. No agreement was 1. reached on that day. However, significant progress was made and the Parties have agreed to exchange additional information. The Parties have also agreed to another mediation session in January 2011
- The Parties believe that an amended procedural schedule is necessary in order to 2. allow the Parties time for further negotiations. As such, all Parties have agreed to the following procedural schedule and are hereby requesting that you issue an order adopting these amended deadlines if you are in agreement with them.

The Office of Public Interest Council is a Party to this proceeding by statute but has not participated to date so their agreement was not sought for this filing.


