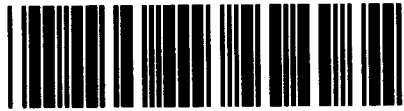

This firm represents the City of Jarrell ("City"). We are in receipt of Ms. Tammy Benter's June 9, 2010 letter. Below is the response of the City to each item requested by Ms. Benter.

1. *Please submit documentation showing the City of Jarrell has a municipally owned water utility and that it is in compliance with commission's minimum requirements for retail public drinking water systems.* The City does not currently have a retail water utility system, but is in the process of setting up a utility department for water and wastewater. In the interim, the City will be providing retail water service through a licensed contract operator.
2. *Submit four (4) copies of any agreements or other documents between the City of Jarrell and Jarrell Schwertner WSC supporting the proposed transaction.* The City provided notice to Jarrell Schwertner WSC of its intent to take over its area over 180 days ago, as required by Texas Water Code, Section 13.255. Since that notice was provided, the City has not reached an agreement with Jarrell Schwertner WSC for the transfer of the service area within the City limits. Therefore, there are no transfer documents to provide. Although discussions are continuing between the



City and Jarrell Schwertner WSC, this is an involuntary statutory CCN transfer at this point in time.
