



Pursuant to our discussion on May 21, and after having had a chance to review the relevant statutes and regulations concerning this matter, I advise that the Utilities and Districts Section draft a notice of deficiency to send to the City of Jarrell regarding its application. Specifically, the City should be asked to demonstrate its qualifications to file a 13.255 application in that it has a municipally owned water or sewer utility and that it is in compliance with the commission's minimum requirements for retail public drinking water systems.

Subsection 13.255(b) of the Water Code is worded such that an application under 13.255 is for the commission to grant single certification to a "municipally owned water or sewer utility or to a franchised utility." From the information submitted by the City, it does not appear that such an entity exists in this case. Absent some further showing that there is a municipally owned water or sewer utility to which single certification can be granted, the application should be returned.

Please let me know if you need any more information or wish to discuss this matter further.
