



GRANTING REQUEST FOR ADDITIONAL ABATEMENT

On August 6, 2007, the City of College Station (College Station or Applicant) timely filed a status report requesting that the abatement period in this case be continued an additional 60 days. The motion is unopposed. A mediation will occur on August 9, 2007.

Applicant's request for an additional abatement period has merit and is GRANTED. College Station shall file a status report on or before August 29, 2007. If a settlement of all contested issues cannot be reached, Applicant may submit a revised schedule or three proposed dates for a prehearing conference.

STATUS REPORT AND UNOPPOSED MOTION TO EXTEND ABATEMENT PERIOD

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

The City of College Station ("College Station") files this Status Report and Unopposed Motion to Extend Abatement Period.

INTRODUCTION

In Order No.9, the last Order issued in this Docket, the ALJ requested that College Station submit a revised schedule or three dates for a prehearing conference, if settlement on all contested issues could not be reached. Settlement negotiations are still active and the parties request further abatement of the schedule in an attempt to settle the matter.

BACKGROUND

A preliminary hearing in the above-captioned matter was held on June 6, 2006. In Order Number 1, the ALJ set out the prehearing and hearing schedule. On August 3, 2006, College Station filed a motion to abate the schedule while the parties conducted settlement negotiations. In Order Number 2, dated August 4, 2006, the ALJ granted the abatement and required College Station to submit a status report on October 3, 2006. On October 3, 2006, College Station filed an unopposed motion to extend the abatement period. College Station settled with all protesting

parties except for Main Street Homes ("MSH") and Wellborn Special Utility District ("WSUD"). In Orders Number 3 and 4, the ALJ dismissed the parties who settled with College Station. In Order Number 5, the ALJ granted College Station's October 3, 2006 request for an extension of the abatement period and ordered College Station to file a status report on or before January 5, 2007. College Station submitted a status report and request for abatement extension, which the ALJ granted in Order Number 6. The ALJ also ordered College Station to file a status report on or before March 5, 2007. College Station submitted a status report and request for abatement extension, which the ALJ granted in Order Number 7. The ALJ also ordered College Station to file a status report on or before June 6, 2007. College Station submitted a status report on June 6, 2007 requesting an additional 60 days to conduct mediation. In Order Number 8, the ALJ granted the extension and required a report on or before August 6, 2007. On that date, College Station requested an abatement to participate in an August 9, 2007 mediation, which the ALJ granted in Order No. 9. A status report is due to the ALJ on or before August 29, 2007.

MSH and WSUD have a CCN application before SOAH in Docket No. 582-07-1251, which College Station contested. ALJ Carol Wood has abated that docket until October 5, 2007. The MSH/WSUD application is to certificate the Meadow Creek subdivision, which MSH is developing. College Station seeks to certificate the subdivision in its application.

STATUS REPORT

On August 9, 2007, College Station and MSH participated in mediation with Plaintiffs in Brazos County District Court litigation in an effort to resolve the CCN dispute. By letter dated August 23, 2007, the Plaintiffs' attorney notified MSH and College Station that Plaintiffs' claims were unresolved by the offers made in mediation.

On August 28, 2007, College Station transmitted a new settlement offer to MSH and WSUD.

MOTION FOR EXTENSION OF ABATEMENT

College Station requests an extension of the abatement while MSH and WSUD are considering College Station's August 28, 2007 settlement proposal. College Station requests that the matter be abated until October 5, 2007, which is the same date of the abated proceeding SOAH Docket No. 582-07-1251, which is related to this proceeding.

CONCLUSION

College Station requests an extension of the abatement. In the event settlement is not completed, College Station will submit a status report to the ALJ on or before October 5, 2007. In the status report, College Station will coordinate with the parties and submit a revised schedule or request additional time for settlement, whichever is necessary. Counsel for College Station has conferred with Leonard Dougal, counsel for WSUD, Rick Jenkins of MSH and MSH's counsel, Mark Zeppa, and Kayla Murray, counsel for the Executive Director. All parties concur with this request.
