ORDER NO. 7

GRANTING REQUEST FOR ADDITIONAL ABATEMENT

On March 5, 2007, the City of College Station (College Station or Applicant) timely filed a status report requesting that the abatement period in this case be continued an additional 90 days. The motion is unopposed. Applicant has been working diligently to resolve all issues in this case. On January 11, 2007, the College Station City Council was scheduled to consider a possible resolution of two issues affecting settlement in this case. However, on January 9, 2007, Main Street Homes-CS, Ltd. (MSH) was sued in district court. Additionally, MSH has a competing sewer CCN application set for preliminary hearing on March 13, 2007. Applicant requests a 90-day extension of the abatement period to determine whether settlement negotiations can be completed. MSH's pending sewer application may also affect this proceeding.

Applicant's request for an additional abatement period has merit and is GRANTED. College Station shall file a status report on or before June 6, 2007. If a settlement of all contested issues cannot be reached, Applicant may submit a revised schedule or three proposed dates for a prehearing conference.
