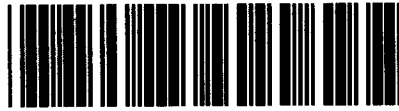

**ORDER NO. 5
REFERRING CASE FOR MEDIATED
SETTLEMENT CONFERENCE**

At the telephonic prehearing conference held on October 24, 2006, the parties in the above-captioned matter agreed to a mediated settlement conference and to continuing the hearing scheduled for October 31, 2006

THEREFORE, IT IS ORDERED:

1. This case is hereby referred to SOAH's Alternative Dispute Resolution Team Leader, Judge Renee M. Rusch, for appointment of a mediator and a period of mediation. With the issuance of this Order, the official file in this case is transferred to Judge Rusch
2. The mediator will schedule a mediated settlement conference in consultation with the parties. The actual date for the mediation will be set by the mediator after consultation with the parties.
3. If mediation is unsuccessful, the case will be returned to the presiding Judge.
4. The hearing on the merits is CONTINUED from October 31, 2006, to an indefinite date in the future.

5. The parties are ordered to appear at the mediated settlement conference with a party representative who has full settlement authority for this matter.
