Dear Board Members:

House Bill 1808, which was passed in the last legislative session, made two significant regulatory changes affecting nonprofit water supply or sewer service corporations (WSCs).

The first change requires all WSCs to file copies of their tariffs with the Commission for informational purposes. You must file a copy of your tariff with the Commission by no later than March 1, 1990. The Commission has not established a specific tariff form for WSCs, but a tariff must contain at least the following items:

1. Cover page with WSC name, CCN number, counties or cities in which the tariff is effective.

2. Listing of all rates and fees charged for service.

3. Service rules, policies and procedures typically used including items such as billing dates, cutoff dates, water rationing plans, and application forms for service and extensions.

A tariff can be extremely valuable to your system because it provides a place where all the information you need in dealing with your members and general system policies can be kept. Because of the special needs of a nonprofit, member-owned system, your tariff should contain additional items related to membership, FmHA requirements, etc. The Texas Rural Water Association, an organization of WSCs located at 6300 La Calma, Suite 120, Austin, Tx., 512-458-8121, is conducting workshops for WSCs and has developed a sample tariff form which could be of benefit to you.

The second change affects utility service areas. Every WSC is now required to have a certificate of convenience and necessity (CCN) which designates its authorized service area. Prior to the passage of H.B. 1808, some WSCs were exempted from the CCN requirements. All uncertificated WSCs must submit a completed application for a CCN by September 1, 1990. In addition, the new legislation defines the limits for extending service to areas "contiguous" to an existing CCN. If you are providing service where the point of use is more than 1/4 mile outside the CCN boundary you must amend your CCN to include these areas.
