On JAN 05 2005, the Executive Director of the Texas Commission on Environmental Quality pursuant to Chapters 5 and 13 of the Texas Water Code considered the applications from the City of Mission to amend Certificates of Convenience and Necessity Nos. 11537 and 20768, to decertify portions of Certificates of Convenience and Necessity Nos. 10559 and 20785 from La Joya Water Supply Corporation, and to decertify a portion of Certificates of Convenience and Necessity No. 10558 from Sharyland Water Supply Corporation in Hidalgo and Starr Counties.

No person has requested a public hearing on the applications;

Notice of the applications was given to all affected and interested parties;

The criteria set forth in *Texas Water Code* Sections 13.246(c) and 13.254 have been considered; and

The certificate amendments requested in these applications are necessary for the service, accommodation, convenience, and safety of the public.

Mr. Guadalupe Garza of La Joya Water Supply Corporation has agreed to the decertifications by letter dated August 31, 2004. Mr. Tim Nicolls, representing Sharyland Water Supply Corporation has agreed to the decertification by letter dated September 10, 2004.

Now, therefore, be it ordered by the Texas Commission on Environmental Quality that the applications are granted and Certificates of Convenience and Necessity Nos. 11537 and 20768 be amended and portions of Certificates of Convenience and Necessity Nos. 10558, 10559 and 20785 be decertified in accordance with the terms and conditions set forth herein and in the certificates.

IT IS FURTHER ORDERED that the City of Mission shall serve every customer and applicant for service within the area certified under Certificates of Convenience and Necessity Nos. 11537 and 20768 and that such service shall be continuous and adequate.

IT IS FURTHER ORDERED that La Joya Water Supply Corporation shall serve every customer and applicant for service within the area certified under CCN Nos. 10559 and 20785 and that such service shall be continuous and adequate.

IT IS FURTHER ORDERED that Sharyland Water Supply Corporation shall serve every customer and applicant for service within the area certified under Certificates of Convenience and Necessity No. 10558 and that such service shall be continuous and adequate
