1 Q. Please state your name and business address.

- 2 A. My name is David M. Welsch. My business address is 933 E. Court St., Seguin, TX 78155.
- 5 Q. Please describe your educational background and professional experience.
- I have a Bachelor of Arts (Business) from Texas Lutheran University. I have worked for 6 A. the Guadalupe-Blanco River Authority (GBRA) for twenty-seven (27) years. During my 7 years at GBRA, I have worked primarily in the development of water and wastewater 8 related projects, including the management of studies, planning for new water and 9 wastewater services, the development of water and wastewater service contracts with 10 municipalities and others and the management of land acquisition programs. My 11 experience includes preparing permits and representing GBRA before state and federal 12 agencies. I have managed area and regional water and wastewater studies. I have 13 worked in the development, permitting and construction of rural wastewater service 14 systems and in the expansion of exiting wastewater systems. I was the principle 15 negotiator for the new wastewater treatment system in the City of Lockhart. 16

- 1 Q. In what capacity are you currently employed with GBRA?
- 2 A. I am currently employed as the Director of Project Development.
- 3
- 4 Q. How long have you been the Director of Project Development?
- 5 A. About 20 years.

- 7 Q. Please describe your job duties and responsibilities at GBRA.
- 8 A. I am responsible for the development of new projects and services for GBRA, including
- 9 municipal water supply, distribution services, and wastewater systems. I serve as the
- principal project manager for contract development, and permit and property acquisitions.
- Specifically, I negotiate water supply contracts, and water and sewer operating
- agreements with other political subdivisions and retail public utilities. I coordinate the
- staff and consultants during the implementation of these newly negotiated contracts. I
- direct regional wastewater planning activities and develop grant applications and seek
- funding assistance for the various wastewater, water supply and distribution projects
- implemented by GBRA. As part of my job duties and responsibilities, I have been
- involved in the negotiations of the contracts between GBRA and Wimberley and have
- 18 coordinated GBRA's assistance with Wimberley's efforts to obtain a CCN to provide
- 19 sewer service to its citizens.

1	Q.	Are you a member of any professional associations?
2	A.	I am a member of the Alamo Area Council of Governments, the Texas Water
3		Conservation Association, the National Water Resource Association, and the American
4		Public Power Association. I am a licensed real estate broker.
5		
6	Q.	Please describe your experience in the area of municipal sewer service.
7	A.	One of the primary purposes of GBRA is to provide regional sewer service within the
8		District. To further that purpose, I have worked with numerous municipal sewer service
9		providers throughout GBRA's service area, examining their sewer needs, their system's
10		capacities, and financial status, and negotiating sewer service agreements as well as
11		operating agreements.
12		
13	Q.	When you are directing regional planning activities and negotiating sewer service
14		agreements and operating agreements with utilities what types of information is it
15		important for you to know and understand?
16	A.	It is important to know and understand the management of sewer utilities, infrastructure
17		capacities, sewer demands and needs, and financial needs.
18		
19	Q.	Have you ever testified before?
20	A.	Yes.

1	Q.	In what cases and in what capacity?
2	A.	I have provided rights-of-way testimony in jurisdictional matters. I have also provided
3		testimony concerning valuation, project needs, and other matters related to GBRA
4		activities. I have also testified in the matter of the creation of a priority groundwater
5		management area for northern Bexar County. Additionally, by the time that I testify in
6		this proceeding I will have testified in the matter of Applications of the City of Bulverde
7		to Obtain and Bexar Metropolitan Water District to Amend Water Certificates of
8		Convenience and Necessity in Comal County. (SOAH Docket Nos. 582-01-3633 and
9		582-02-0432; TNRCC Docket Nos. 2001-0697-UCR and 2001-0951-UCR.)
10		
11	Q.	Have you prepared a resume describing your experience?
12	A.	Yes. My resume is attached to my testimony as Wimberley Exhibit 25.
13		
14	Q.	What is GBRA's connection with or relationship to Wimberley?
15	A.	Wimberley and GBRA have entered into an Interlocal Agreement and an Operating
16		Agreement for GBRA to design, construct, finance, operate, and maintain the sewer
17		system for Wimberley. GBRA has also agreed to assist Wimberley in obtaining a sewer
18		certificate of convenience and necessity (CCN) for Wimberley's requested service area.
19		
20	Q.	Have you reviewed Wimberley's CCN application?

1	A.	Yes.
2	Q.	Have you reviewed the amendments to Wimberley's CCN application?
3	A.	Yes.
4		
5	Q.	Are you familiar with the area Wimberley is requesting to serve?
6	A.	Yes.
7		
8	Q.	Could you please describe the area to be served?
9	A.	The requested area is in Hays County, Texas. The requested area includes the city limits
10		of Wimberley and its extraterritorial jurisdiction, which extends one mile from the
11		Wimberley city limits. It excludes those areas that have previously been certificated to
12		other utilities except for a small area recently certificated to Woodcreek Utilities Inc. A
13		map of the requested area is attached to Steve Klepfer's prefiled testimony as Wimberley
14		Exhibit 12.
15		
16	Q.	Is Hays County within the statutory service area and jurisdiction of GBRA?
17	A.	Yes.
18		
19	Q.	Were you involved in negotiating and drafting of the Operating Agreement and an
20		Interlocal Agreement with Wimberley?

3	Q.	Please generally describe the basic provisions of the Interlocal Agreement and the
4		Operating Agreement between Wimberley and GBRA?
5	A.	As described in the Operating Agreement, GBRA has agreed to design, permit, finance,
6		construct, operate and maintain a sewer system for Wimberley. The system will collect,
7		treat, and dispose of wastewater from Wimberley. In the Interlocal Agreement, GBRA
8		has agreed that the services it is providing to Wimberley under the Operating Agreement
9		will be used to serve the customers in Wimberley's requested service area. GBRA's
10		services will be compensated in accordance with the provisions of the Operating
11		Agreement. I have attached a certified copy of the Interlocal Agreement to my testimony
12		as Wimberley Exhibit 26. I have also attached a certified copy of the Operating
13		Agreement to my testimony as Wimberley Exhibit 27.

15	Q.	Who will handle the accounting, billing, collections, and customer service for the
16		Wimberley sewer system?
17	A.	GBRA.
18		
19	Q.	How will the sewer system be financed?
20	A.	GBRA will finance the system, including issuing debt, if necessary.

1	Q.	For what purposes will the fees and monies collected by GBRA under the Operating
2		Agreement be used?
3	A.	On behalf of Wimberley, GBRA will collect fees and monies from the retail customers to
4		pay for the costs and services associated with the collection, treatment, and disposal of
5		wastewater through the Wimberley sewer system, including operation and maintenance
6		costs, debt service requirements, and bond requirements.
7		·
8	Q.	What sewer service is currently being provided to the requested area?
9	A.	To the best of my knowledge, no sewer service by a utility is being provided in the
10		requested area, with one exception. AquaSource Utility Inc. is providing sewer service in
11		41

Do you believe there is a need for sewer service in the requested area?

Wimberley has received numerous oral and written requests for sewer service. I have 1 A. read these requests for sewer service. They have been included as part of Wimberley's 2 CCN application. Also, I have reviewed the Wimberley Regional Wastewater Planning 3 Study prepared by GBRA and the R.J. Brandes Company, with funding from the Texas 4 5 Water Development Board. Based on my review of that study, I have concluded there is 6 a need for sewer service because Wimberley is rapidly growing. Most of the current 7 Wimberley population is on septic systems. With the increased population, and 8 environmentally-sensitive character of the requested area, there are potential problems 9 involving immediate and long-term impacts on water and land resources in the requested 10 area. Management and control of the requested area's wastewater is needed to protect 11 these resources and to meet the needs of the growing population. A certified copy of the 12 Wimberley Regional Wastewater Planning Study is attached to my testimony as 13 Wimberley Exhibit 28. 14 15 Are you familiar with where those requests for sewer service are located within the Q. 16 requested area? 17 Yes. They are located throughout the requested area. A map that depicts Wimberley's A. requested area and the locations of the requests for sewer service that have been received 18

by Wimberley is attached to Steve Klepfer's prefiled testimony as Wimberley Exhibit 15.

1	Q.	Are you familiar with the other utilities serving in the proximate area to Wimberley's
2		requested area?
3	A.	Yes.
4		
5	Q.	What other utilities are currently providing sewer service within two miles of
6		Wimberley's requested area?
7	A.	AquaSource Utility, Inc., ("AquaSource") which has taken over the operations of
8		Woodcreek Utilities, Inc., and Blue Hole Management, Ltd. ("Blue Hole").
9		
10	Q.	Have you considered the ability of the utilities providing sewer service in the proximate
11		area to provide sewer service to their respective customers?
12	A.	Yes.
13		
14	Q.	Have you considered the ability of these utilities to provide sewer service to Wimberley's
15		requested area?
16	A.	Yes.
17		
18	Q.	What information did you review?
19	A.	The Regional Wastewater Planning Study for the Wimberley, the draft work on the
20		Wimberley Wastewater Masterplan, and correspondence and material from Wimberley,

as well as the Wimberley CCN application. 2 Do you have any concerns about the sewer service those utilities currently provide to 3 Q. their respective certificated areas? What are those concerns? 4

There is customer dissatisfaction with the existing, limited service in the area, and an A. overall concern that service by existing providers to new areas would be unreliable, costly, and unresponsive to the citizens needs. There is also a concern that others may have aggressive approaches to systems that provide treated discharge of effluent into area streams.

11 Q. Do you have concerns about those utilities' ability to provide sewer service to

12 Wimberley's requested area? What are those concerns?

13 A. I am concerned that these utilities do not have sufficient capacity to serve the entire 14 requested area. I am aware that AquaSource has had customer service and billing 15 problems and has also had compliance problems with its Woodcreek system. I am also 16 concerned that, because these entities are investor-owned utilities and to date have not 17 sought to certificate all of Wimberley's requested area, they are under no obligation to 18 provide sewer service to the requested area. These is no guarantee that Blue Hole or 19 AquaSource will certificate Wimberley's requested area in the future and thus obligate 20 themselves to provide sewer service.

1	Q.	How would you compare the sewer service that Wimberley and GBRA, acting as the
2		operator for the Wimberley system, will be able to provide to the requested area with the
3		sewer service that any of the neighboring utilities would be able to provide to
4		Wimberley's requested area?
5	A.	GBRA is a regional sewer service provider, with many years of experience in providing
6		sewer service. GBRA possesses the managerial, technical, and financial resources to
7		meet the sewer needs of the requested area. GBRA presently operates small rural
8		systems as well as large municipal systems. GBRA operates on a cost of service basis.
9		GBRA has a staff of trained, professional engineers, water quality specialists, and
10		operators dedicated to the design, construction and operation of these systems. GBRA
11		has a history of working with municipalities to address their concerns and meet their
12		needs.
13		
14	Q.	Based on your review of the neighboring utilities, will granting the sewer CCN to
15		Wimberley have an adverse impact on the other retail service providers serving in the
16		proximate area?
17	A.	No. To the best of my knowledge, except for the area recently certificated to Woodcreek
18		Utilities (AquaSource), these systems do not currently provide sewer service in the
19		requested area. Those utilities will be able to focus on serving the areas they already
20		currently serve and to ensure there is an adequate sewer service for their current and

1		future customers in their respective service territories.
2		
3	Q.	Is it feasible to obtain sewer service in the requested area from another utility providing
4		sewer service in the proximate area? Why?
5	A.	For a majority of the requested area, it is no more feasible to obtain sewer service from
6		the another utility than it will be to obtain sewer service from Wimberley. For the areas
7		within one-quarter mile of the service areas of Blue Hole and AquaSource, and along
8		AquaSource's sewer lines on FM 2325, the feasibility of obtaining sewer service from
9		AquaSource or Blue Hole is uncertain because neither AquaSource nor Blue Hole are
10		obligated to provide sewer service to those areas. Moreover, I do not believe Blue Hole
11		and AquaSource have the capacity to provide sewer service to all the potential customers
12		in the requested area.
13		
14	Q.	In your opinion, does Wimberley have the ability to provide continuous and adequate
15		sewer service to the requested area?
16	A.	Yes. Consistent with the contractual relationship between GBRA and Wimberley,
17		through the Operating Agreement, and the Interlocal Agreement, Wimberley has the
18		ability to provide continuous and adequate sewer service to the requested area.
19		
20	Q.	In your opinion, will sewer service by Wimberley, with GBRA as the operator, improve

sewer service to the customers in the requested area? 1 Yes. Very limited sewer utility service is currently available in the requested area, and A. 2 based on the growth estimates in the Wimberley Regional Wastewater Planning Study, 3 4 attached to my testimony as Wimberley Exhibit 28, there is a need for sewer service in the area. Thus, sewer service in the requested area by Wimberley will be an 5 6 improvement. 7 8 Q. Can Wimberley provide sewer service to the requested area with equal or improved 9 service than that which would be provided by other retail public utilities? Why? 10 Yes. Through its contractual relationship with GBRA, Wimberley will be able to ensure A. 11 the type of sewer service that is provided to the requested area complies with applicable 12 regulatory standards and is continuous and adequate to meet the sewer needs of 13 customers within the requested area. 14 15 In your opinion, will granting the CCN have a negative impact on Wimberley? Q. No. As provided by the agreements between GBRA and Wimberley, GBRA will own the 16 A. 17 infrastructure until such time as Wimberley is willing and able to purchase the sewer 18 system. Payment for the infrastructure will be recouped through fees and sewer rates. 19 Also, GBRA will operate and maintain the system, including billing, collections, and 20 customer services. Therefore, there will be no need for Wimberley to hire additional staff

1		to operate or maintain the sewer system.
2		
3	Q.	In your opinion does Wimberley, with GBRA as the operator of the system, possess the
4		managerial and technical capability to provide continuous and adequate sewer service to
5		the requested area?
6	A.	Yes.
7		
8	Q.	In your opinion, is granting the CCN to Wimberley necessary for the service,
9		accommodation, convenience, or safety of the public?
10	A.	Yes. It will ensure there is adequate sewer service in the requested area and eliminate the
11		need for septic systems, which can be harmful to the groundwater, rivers, and creeks in
12		the Wimberley's requested area.
13		
14	Q.	Does this conclude your testimony?
15	A.	Yes. I reserve the right to amend or supplement my testimony at the time of trial to
16		correct any inadvertent mistakes and to reflect changes in circumstances.
