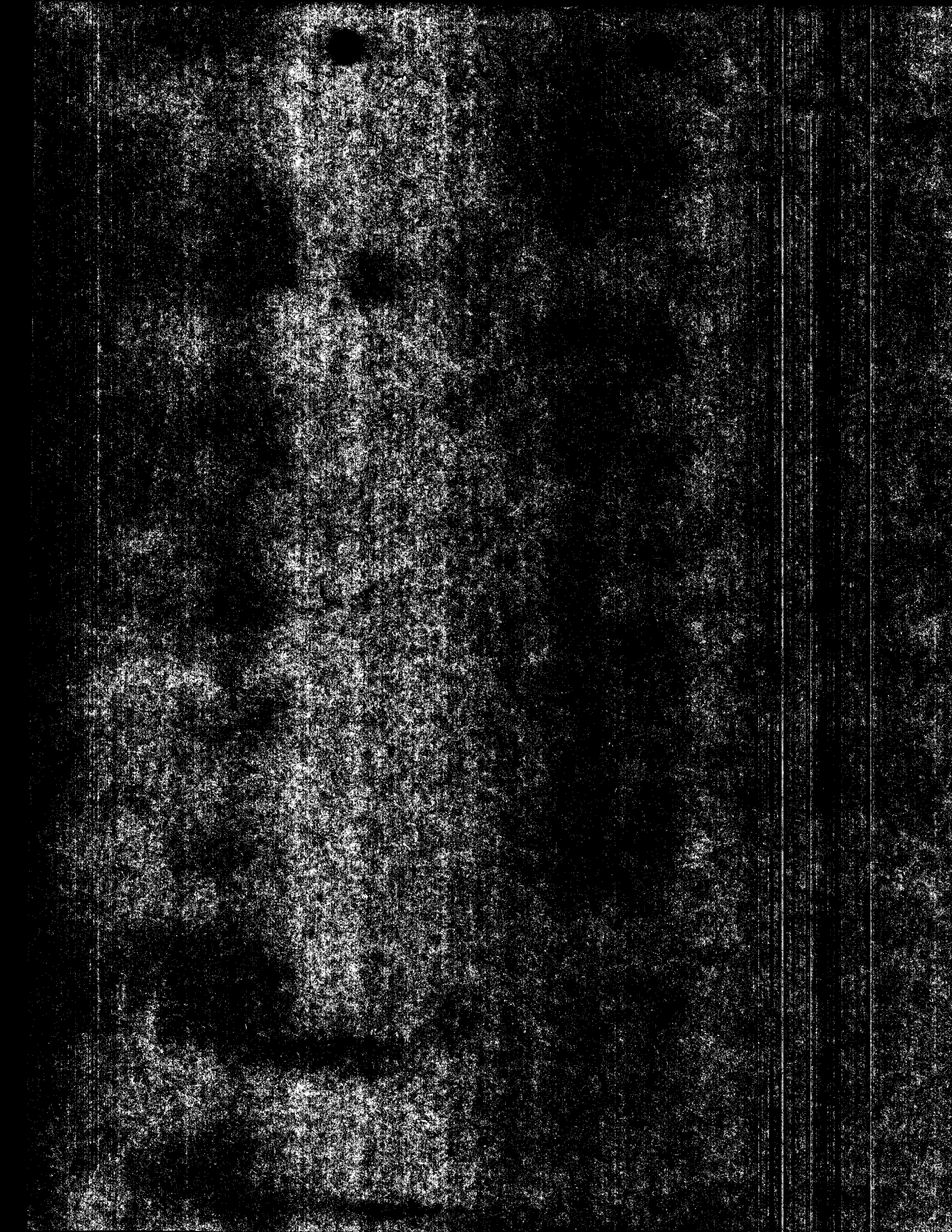

Mr. Nikorak,

I don't see how I can possibly get to the hearing Monday morning. If you don't mind trying to represent my interests, I would greatly appreciate your help.

I own 24 apartments at the entrance of the Northwest Hills subdivision in Fredericksburg, Texas. I have 12 water meters serviced by Aqua Texas. Those meters are 1" which is charged an even higher rate than the residential meters which are normally 5/8" - 3/4". I have always paid the water bill for the tenants at these apartments as the previous landlords had done. My bill went from an average of \$600 per month for all 24 units to over \$1700 per month, over a 280% increase!

I have attached the proxy form with all 12 meters/accounts listed. If you need anything further to represent me at the Austin meeting, please email me. Do you think meter numbers would be necessary since my bills are mailed to my office address, 240 W. Main, and don't actually list the street addresses of the units on the bills, only the unit numbers?

**WHEREAS**, unfair and/or unjustified water rate increases could have a detrimental effect to the economic impact to Gillespie County; and


**WHEREAS**, the Gillespie County Commissioners Court is concerned over the increase in water rates to many of its citizens; and




