





Applicant, the Town of Westlake, Texas ("Westlake") serves this Request for Disclosure, Interrogatories, and Production of Documents on Circle T MUDs 2 and 3, through their attorney of record, Andrew N. Barrett, pursuant to Chapter 2001 of the Texas Government Code, the Texas Rules of Civil Procedure, and applicable rules and regulations of the Texas Natural Resource Conservation Commission and State Office of Administrative Hearings.

A. DEFINITIONS

The following definitions apply to this discovery request:

1. "Application" means the Town of Westlake's Application for a Sewer Certificate of Convenience and Necessity ("CCN") filed at the Texas Natural Resource Conservation Commission ("TNRCC") and any and all information gathered, generated, compiled, or submitted to any other local, municipal, county, state or federal agency by or on behalf of the Town, to further its goal of the securing this Sewer CCN.

- 2. "Applicant" and "Town" refer to the Town of Westlake, Texas, and each of its officers, employees, agents, representatives, attorneys, and all other natural persons, business or legal entities, presently or formerly acting in concert with, under their direct or indirect control of, or on behalf of the Town of Westlake.
- 3. "Communication" means any oral, written or electronic communication.
- 4. "Concerning" means, in whole or in part, directly or indirectly, referring to, relating to, being connected with, commenting on, responding to, showing, describing, analyzing, reflecting, embodying, mentioning, or constituting the subject matter identified in the request.
- 5. "Date" means the exact day, month, and year, if ascertainable or, if not, the best approximation.
- 6. "Describe" or "identify," when used in reference to a document, means you must state, to the fullest extent possible, the following:
 - a) The nature (e.g., letter, handwritten note) of the document;
 - b) The title or heading that appears on the document;
 - c) The date of the document and the date of each addendum, supplement, or other addition or change;
 - d) The identity of: the author of the document; any signatory or signatories of the document; and the person on whose behalf or at whose request or direction the document was prepared or delivered; and
 - e) The present location of the document, and the name, address, position or title, and telephone number(s) of the person(s) having custody of the document.
- 7. "Describe" or "identify," when used in reference to a person, means you must state, to the fullest extent possible, the following:
 - a) The person's full name;
 - b) The person's present or last known residential address, including zip code;

- c) The person's present or last known occupation, job title, employer, employer's address, including zip code, and employer's telephone and facsimile number(s);
- d) The occupation, job title, employer, and employer's address at the time of the event or period referred to in each particular interrogatory; and
- e) In the case of any person other than an individual, identify the officer, employee, or agent most closely connected with the subject matter of the interrogatory, and the officer who is responsible for supervising that officer or employee.
- 8. "Describe" or "identify," when used in reference to an entity, means you must state, to the fullest extent possible, the following:
 - a) The entity's full and correct legal name;
 - b) The nature of the entity's structure and/or organization;
 - c) The address, telephone and fax number of the entity's principal offices;
 - d) The principal line(s) of the entity's business or activity; and
 - e) The officer, employee, or agent most closely connected with the subject matter of the interrogatory, and the officer who is responsible for supervising that officer or employee.
- 9. "Districts" mean the Circle T MUDs 2 and 3, and each of their officers, employees, agents, representatives, attorneys, and all other natural persons, business or legal entities, presently or formally acting in consent with, under their direct or indirect control of, or on behalf of the Circle T MUDs 2 and 3.
- 10. "Document(s)" means all written, typed, or printed matters, and all magnetic or other records, papers, or documentation of any kind or description (including, without limitation, letters, correspondence, telegrams, memoranda, notes, minutes, contracts, agreements, notations of telephone or in-person conversations, conferences, inter-office communications, E-mail, microfilm, bulletins, circulars, accounts, writings, drawings, graphs, charts, pamphlets, books, facsimiles, invoices, tape recordings, video recordings, photographs, computer printouts and work sheets), including all originals and all drafts and copies not identical to the originals, all photographs and

graphic matter, however produced or reproduced, and all compilations of data from which information can be obtained, and any and all writings or recordings of any type or nature, whether or not prepared by you, in your actual possession, custody, or control, including those in the possession, custody, or control of any and all present or former directors, officers, employees, representatives, consultants, accountants, attorneys, agents, other natural persons, business or legal entities, presently or formerly acting in concert with, under the direct or indirect control of, or on behalf of Protestant.

- 11. "Entity" means any partnership, association, corporation, joint venture, firm, proprietorship, agency, board, authority, commission, governmental body, trust, contractor, or any other organization, legal or business entity, and all other predecessors or successors in interest.
- 12. "Person(s)" means any natural person.
- 13. The word "and" means "and/or."
- 14. The word "or" means "or/and."
- 15. "You" and "your" mean Circle T MUDs 2 or 3 and all other natural persons, businesses or legal entities, presently or formerly, acting in concert with, under the direct or indirect control of, or on behalf of Circle T MUDs 2 or 3.

B. INSTRUCTIONS

- (1) You may not object to requests for disclosure. As to any interrogatory or request for production to which you do not respond, please state the grounds for your refusal or inability to respond. When you believe that a complete answer to a particular interrogatory or request for production or part thereof is not possible, please answer each request for production to the extent possible and furnish a statement explaining: 1) the reason for your inability to respond further; and 2) whatever information or knowledge you have concerning the non-responsive portion.
- (2) For each document or other requested information that you assert is privileged or is not discoverable, other than requests for disclosure, identify that document or other requested information, and state the specific grounds for the claim of privilege or other ground for exclusion. Also, for each document you assert is not discoverable, state the date of the document; state the name, job title, and address of the person who prepared it; state

the name, address, and job title of the person to whom it was addressed, circulated, or who saw it; state the name, job title, and address of the person now in possession of the document; describe the subject matter of the document; and state the present location and the custodian for the document.

- (3) For every document that no longer exists or cannot be located, or for any requested information about a document that no longer exists or cannot be located: identify the document; state how and when the document passed out of existence, or when it could no longer be located; and state the reason(s) for the disappearance; identify each person having knowledge about the disposition or loss of the document; and identify each document evidencing the existence or nonexistence of each document that cannot be located.
- (4) It is requested that all documents that might impact on the subject matter of the Application or the Districts' Sewer CCN application be preserved and that any ongoing process of document destruction involving such documents cease.
- (5) Furnish all information available to you and known by you, or in your possession or that of your agents and attorneys, or appearing in your records.
- (6) In those instances where you choose to answer an interrogatory by referring to a specific document or record, it is requested that the specification be in sufficient detail to permit the requesting party to locate and identify the record(s) and/or document(s) from which the answer is to be ascertained, as readily as can the party served with the request.
- (7) In those instances when requested information or requested documents are stored only on software, computer based information, or other data compilations, you should either produce the raw data along with all codes and programs for translating it into usable form, or produce the information in a finished usable form that includes all necessary glossaries, keys, and indices for interpretation of the material.
- (8) Please respond to each interrogatory and each request for production in the space provided. If you need additional space within which to respond to an interrogatory or request, please add pages as necessary, and indicate clearly the interrogatory or request for production to which each response is responsive. When interrogatories or requests for production contain

- subparts, indicate in your answer the subpart to which each particular part of your response is in response.
- (9) You are under a duty to supplement your answers to these interrogatories, responses to these requests for disclosure, and responses to these requests for production that are incomplete or incorrect when made. Furthermore, you are under a duty to timely amend your answers if you obtain information on the basis of which you know that an answer either: 1) was incorrect or incomplete when made; or 2) although correct and complete when made, is no longer true and complete and the circumstances are such that failure to amend the answer is in substance misleading.

- 4. Please describe the factual bases and legal theories for your claims that the Sewer CCN should be granted to the Districts and denied to Westlake.
