ORDER

On APR 14 1993, the Texas Water Commission pursuant to Chapter 13 of the Texas Water Code considered the application of Hall & Boustead, Inc. dba Frontier Park Resort Water System for a Water Certificate of Convenience and Necessity in Sabine County. After considering the evidence, including the staff recommendation, the Commission finds that:

No person has requested a public hearing on the application;

Notice of the application was given all affected and interested parties;

The applicant's system fails to meet the Commission's rules for public water systems by having failed to install accurate metering devices at every retail and commercial connection and by charging a flat rate which does not encourage conservation and may be discriminatory.

The criteria set forth in Section 13.246(c) have been considered by the Commission;

Granting the application is necessary for the service, accommodation, convenience and safety of the public.

NOW, THEREFORE, BE IT ORDERED BY THE TEXAS WATER COMMISSION that the application is granted and Certificate of Convenience and Necessity No. 12689 is issued to Hall & Boustead, Inc. dba Frontier Park Resort Water System in accordance with the terms and conditions set forth herein and in the certificate.

IT IS FURTHER ORDERED that Hall & Boustead, Inc. dba Frontier Park Resort Water System shall serve every customer and applicant for service within the area certified under Certificate of Convenience and Necessity No. 12689 and that such service shall be continuous and adequate.

BE IT FURTHER ORDERED that Hall & Boustead, Inc. dba Frontier Park Resort Water System shall install accurate metering devices at every retail and commercial connection by May 30, 1994 and subsequently submit a rate change application to convert to metered rates immediately following completion of meter installations. Upon completion of these requirements the applicant must notify the Monitoring and Enforcement Section of the Commission's Water Utilities Division in writing of its compliance making reference to this order and Application Number.



NOTICE OF VIOLATION

Re: Hall & Boustead, Inc. dba Frontier Park Resort; Water Utility Service in Sabine County; Public Water System (PWS) ID No. 2020028; Certificate of Convenience and Necessity (CCN) No. 12689

Dear Mr. Neal:

The Utilities and Districts Section of the Texas Commission on Environmental Quality (Commission) has been advised that Hall & Boustead, Inc. dba Frontier Park Resort has been Sold, Transferred, or Merged with another system and may be providing water service for compensation and therefore, operating as a retail public utility. All Sales, Transfers, and Mergers must be reported to the Commission 120 days prior to the transaction.

A public water utility is any person, partnership, corporation or cooperative cooperation that owns or operates facilities for compensation for sale or resale of potable water to the public, regardless of the number of connections served. Public water utilities are under the Commission's original service rule and rate setting jurisdiction and must have a CCN and tariff. Public water utilities must also provide continuous and adequate service.

Please respond to this letter in writing by **June 25, 2004**, by submitting a completed STM application. I have enclosed a STM application with this letter. Failure to comply with the Texas Water Code and Commission rules will result in enforcement action against your utility.

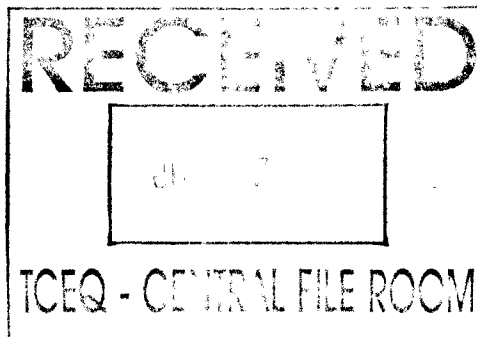
