Dear Judge Rogan:

The City of Ovilla and the City of Glenn Heights have reached an agreement in principle to settle their disputes regarding the captioned matter. Today, the cities met with representatives of the Texas Commission on Environmental Quality ("TCEQ") to discuss the procedures to be followed to implement the terms of that settlement agreement. The cities are optimistic that in the relatively near future they will be able to execute a settlement agreement, and file a joint motion with SOAH asking that Ovilla's application be remanded to the TCEQ so that the agency may revise the cities' CCNs to implement the terms of the settlement agreement. Accordingly, the City of Ovilla and the City of Glenn Heights request that this matter be abated for an additional forty-five days so that the cities may move forward with the settlement process. During today's meeting, the Executive Director indicated he would not oppose this request.

The City of Ovilla filed an application with the Texas Commission on Environmental Quality ("TCEQ") to amend its water Certificate of Convenience and Necessity ("CCN") No. 11459. The City of Glenn Heights requested a contested case hearing on Ovilla's application. The TCEQ granted Glenn Heights' request and referred the application to the State Office of Administrative Hearings for a hearing SOAH has set a preliminary hearing on Ovilla's application for May 31, 2006.

The two cities have agreed in principle to a resolution of their disputes regarding Ovilla's CCN application. The City of Ovilla has notified the Executive Director of the cities' agreement in principle. The City of Ovilla, the City of Glein Heights and the Executive Director request that this matter be abated for 45 days so that the cities may attempt to finalize their negotiations and execute a settlement agreement.
