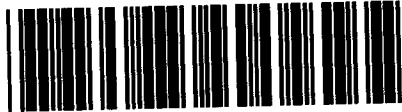

**ORDER NO. 2  
EXTENDING ABATEMENT**

On July 13, 2006, the Applicant (the City of Ovilla) submitted a request to extend by 45 days the presently effective abatement of the captioned proceeding, in order to allow the parties an opportunity to conclude an existing agreement in principle that would settle the dispute between the Cities of Ovilla and Glenn Heights. The request also noted that the Executive Director is amenable to the extended abatement.

The ALJ concludes that the Applicant's request is appropriate and will extend the abatement of this matter through the next scheduled status report.


**STATUS REPORT**

The Applicant is requested to submit a brief written status report by **September 4, 2006**, describing the state of consultations among the parties and including, if appropriate, a procedural schedule leading to a reasonably expeditious evidentiary hearing. The schedule should reflect the agreement of all parties. If agreement cannot be reached, all parties may submit separate scheduling proposals (and status reports, if desired) by the September 4 deadline.
