#### FINAL NOTICE OF DEFICIENCY

Dear Mr. McDonald:

To date we have not received the required information necessary to proceed with the City of Ovilla's applications.

As stated in our letter dated September 23, 2005, the next step towards having your applications accepted is to provide the **revised** public notices without delay. The notice to the public must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Dallas and Ellis Counties. It is the responsibility of the applicant to provide correct notice of the applications to any sewer utilities within five (5) miles and water utilities within two (2) miles of your proposed service area, any city with an extraterritorial jurisdiction which overlaps the proposed service area or other affected parties in your requested area. You will also be required to provide mailed notice to all landowners included in your proposed CCN area pursuant to commission order dated October 21, 2004. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies. Check the notices carefully before mailing or publishing.

A review of our files and maps indicates that, in addition to the neighboring utilities noted on your applications, you must provide notice to the following utilities:

Information related to utilities and districts including addresses can be obtained from the TCEQ web site located at www3.tceq.state.tx.us/iwud.

As proof that notice was provided, you are required to send us the following:

- an original and three copies of a publisher's affidavit of the newspaper publication with tear sheets of the published notice attached;
  - b) four copies of each individual notice and map sent to neighboring utilities and affected parties;
  - one copy of the landowner notice and map sent to each landowner; and
  - an original and three copies of the signed affidavits that individual notice to neighboring utilities, affected individuals <u>and each landowner</u> has been given. (Copies of the Affidavit forms are enclosed with this letter.)

Include a location map delineating the proposed service area with your individual notices to neighboring utilities, other affected parties and each landowner.

There also appears to be an overlap of your proposed service area with the certified service area of the City of Glenn Heights.

Please provide written documentation on how the overlap will be handled. There are several options to resolving this overlap. One is to amend your applications by submitting revised maps and change the requested CCN area so as to not include the area of overlap. The second option is for you to meet with the City of Glenn Heights and work out an agreement whereby the City of Glenn Heights agrees to decertification of the area of overlap. Written documentation from the City of Glenn Heights agreeing to decertification is required. If an agreement is not reached, you would have to provide compelling evidence that the City of Glenn Heights could not provide acceptable service. The notices have been revised to propose decertification of the portions of the City of Glenn Heights in the event this is considered.

In addition to the notice requirements the following information is also necessary to proceed with your applications:

- a) Provide copies of any additional letters of intent from developers, landowner requests, applications for service or a combination of the above to justify the need for water and sewer service in the requested area.
- b) Indicate on a copy of a map submitted in the original applications the location of the current water and sewer connections and the requests for service received for water and sewer for the proposed area.
- c) Provide copies of the most recent water and sewer inspection reports. For each of the

systems deficiency listed in the inspection report letters, attach a brief explanation listing the actions taken or being taken to correct the listed deficiencies, including the proposed completion dates. This information was also requested in a letter from Ms. Peggy Fox dated September 9, 2005.

d) (-

Submit copies of written requests seeking to obtain sewer service from the 2 mile utility, Community Water Service, and the City of Glenn Heights, the City of DeSoto, Sardis Lone Elm WSC, the City of Red Oak and Rockett SUD or documentation that it is not economically feasible to obtain service from them. Also submit copies of written responses from each of these systems or evidence that they did not reply.

- e) Please submit the digital data for the map submitted with the original applications.
- f) You will also be required to provide landowners consent for all proposed areas located outside the City of Ovilla's current extraterritorial jurisdiction.

These items must be completed and returned by <u>November 25, 2005</u>. Processing of these applications cannot proceed until the close of the 30 day public comment period which begins after all the required notices have been given. If we do not receive the requested information by this date, your applications will be returned for failure to prosecute.

Your CCN applications for the City of Ovilla, received on September 1, 2005, have been assigned Application Nos. 35087-C and 35088-C, but have not been accepted for filing. Please refer to these numbers in future correspondence.

The next step towards having your applications accepted is to provide the revised public notices without delay. The notice to the public must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Dallas and Ellis Counties. It is the responsibility of the applicant to provide correct notice of the applications to any sewer utilities within five (5) miles and water utilities within two (2) miles of your proposed service area, any city with an extraterritorial jurisdiction which overlaps the proposed service area or other affected parties in your requested area. You will also be required to provide mailed notice to all landowners included in your proposed CCN area pursuant to commission order dated October 21, 2004. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies. Check the notices carefully before mailing or publishing.

There also appears to be an overlap of your proposed service area with the certified service area of the City of Glenn Heights.

Please provide written documentation on how the overlap will be handled. There are several options to resolving this overlap. One is to amend your applications by submitting revised maps and change the requested CCN area so as to not include the area of overlap. The second option is for you to meet with the City of Glenn Heights and work out an agreement whereby the City of Glenn Heights agrees to decertification of the area of overlap. Written documentation from the City of Glenn Heights agreeing to decertification is required. If an agreement is not reached, you would have to provide compelling evidence that the City of Glenn Heights could not provide acceptable service. The notices have been revised to propose decertification of the portions of the City of Glenn Heights in the event this is considered.

In addition to the notice requirements the following information is also necessary to proceed with your applications:

- a) Provide copies of any additional letters of intent from developers, landowner requests, applications for service or a combination of the above to justify the need for water and sewer service in the requested area.
- b) Indicate on a copy of a map submitted in the original applications the location of the current water and sewer connections and the requests for service received for water and sewer for the proposed area.
- Provide copies of the most recent water and sewer inspection reports. For each of the systems deficiency listed in the inspection report letters, attach a brief explanation listing the actions taken or being taken to correct the listed deficiencies, including the proposed completion dates. This information was also requested in a letter from Ms. Peggy Fox dated September 9, 2005.

- Submit copies of written requests seeking to obtain sewer service from the 2 mile utility listed above and the City of Glenn Heights, the City of DeSoto, Sardis Lone Elm WSC, the City of Red Oak and Rockett SUD or documentation that it is not economically feasible to obtain service from them. Also submit copies of written responses from each of these systems or evidence that they did not reply.
- e) Please submit the digital data for the map submitted with the original applications.
- f) You will also be required to provide landowners consent for all proposed areas located outside the City of Ovilla's current extraterritorial jurisdiction.

Your applications have received a preliminary review of your financial and managerial capability to provide service to the requested area. No additional financial information is required at this time, but you may be asked for additional information after a comprehensive review.

These items must be completed and returned by <u>October 28, 2005</u>. Processing of these applications cannot proceed until the close of the 30 day public comment period which begins after all the required notices have been given. If we do not receive the requested information by this date, your applications will be returned for failure to prosecute.
