
In response to COMMISSION STAFF'S RESPONSE TO ORDER NO. 1, Docket No. 44236, Application For A Water Or Wastewater Rate/Tariff Change filed by Custom Water Company, LLC., we request the following information be documented and considered official response to the insufficiency ruling against the application's completeness.

As discussed with Katherine Gross on February 11, 2015, the online fillable application does not allow the entry of the information as required per the staff's response. Photographic proof of this has been forward to Ms. Gross on February 13, 2015 via email. In correction to the information required in the blanks on page 13 of the application, the test year should be listed as 9/1/2013 to 9/1/2014, as shown on the attached Profit and Loss, pages 61-64 of the application.

In response to the deficiency noted on page 9 of the application, the online fillable form does not allow the entry of alphabetical letters and accepts numeric values only. As there were multiple items pertaining to each line, an additional depreciation schedule was attached to the application which included all installation years and the service life of each item. The schedule is noted as pages 42-60 of the submitted application.

We respectfully request an additional review of the application in hopes of staff deeming it adequate and approving the time line of the original request.
