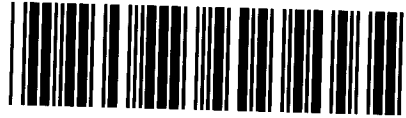

**ORDER NO. 6
DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,
ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE**

I. Application

On January 13, 2015, Double Diamond d/b/a The Cliffs Resort (Applicant) filed an application to amend its water and sewer certificates of convenience and necessity in Palo Pinto County. On February 19, 2015, Order No. 2 was issued finding the application administratively incomplete and deficient, and establishing a deadline and opportunity to cure. On April 10 and September 22, 2015, Applicant filed supplemental information to cure the deficiencies in the application.

II. Administrative Completeness

On October 28, 2015, Commission Staff filed additional comments on the sufficiency of the application. Commission Staff finds that the application is sufficient for further review. Consistent with Commission Staff's recommendation, the application is deemed administratively complete.

III. Notice

Commission Staff recommends that notice be issued as described in Commission Staff's October 28, 2015 filing and the attached memorandum of Emily Sears and Tracy Montes of the Commission's Water Utility Regulation Division, using the attached forms.

Consistent with Staff's recommendation, Applicant shall provide notice as described in Staff's October 28, 2015 recommendation and file affidavits evidencing proof of notice by the deadline set forth below.


IV. Procedural Schedule

The following procedural schedule is adopted:

| Event | Date |

| Deadline for Applicant to provide the Commission with the Affidavits of Notice, the individual notice issued with the accompanying map, and the published notice | November 12, 2015 |
| Deadline for affected persons to file a written protest or to intervene, deadline for affected persons to file comments, and deadline to request a hearing on the merits | 30 days after Applicant mails or publishes notice, whichever occurs later |
| Deadline for Commission Staff to request a hearing, file a final recommendation, or to file a supplemental procedural schedule | January 5, 2016 |
