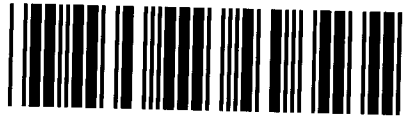

**DOUBLE DIAMOND UTILITIES, INC. DBA THE CLIFFS RESORT'S  
RESPONSE TO ORDER NO. 1**

COMES NOW, Double Diamond Utilities, Inc. dba The Cliffs Resort ("Double Diamond"), by and through its attorneys of record, and files this Response to Order No. 1 and would show the following:

**I. BACKGROUND**

On January 13, 2015, Double Diamond filed an application to amend its water Certificate of Convenience and Necessity ("CCN") No. 12087 and its sewer CCN No. 20705 in Palo Pinto County, Texas, under TEX. WATER CODE ANN. §§ 13.246, 13.254 and P.U.C. SUBST. R. 24.105. The requested amendment is sought to amend the CCNs to include an area developed subsequent to the original development and where services are already being provided.

On January 20, 2015, the Administrative Law Judge ("ALJ") issued Order No. 1 ordering PUC Staff to file comments on the administrative completeness of the application and the proposed notice by February 12, 2015. Order No. 1 also ordered Double Diamond and PUC Staff to file comments on how the application should be processed and to file a proposed procedural schedule by February 12, 2015.

## II. PROPOSED PROCEDURAL SCHEDULE

Double Diamond has been informed that the PUC Staff has determined the application cannot be deemed administratively complete due to certain deficiencies, and has reviewed Staff's Response to Order No. 1 filed today. Double Diamond supports Staff's proposed procedural schedule set forth in that filing.
