

AN ORDINANCE AMENDING CERTAIN PORTIONS OF APPENDIX A, SECTION 11.100, OF THE CODE OF ORDINANCES OF THE CITY OF ORANGE, TEXAS PERTAINING TO UTILITY SERVICE RATES AND CHARGES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ORANGE,

TEXAS:

Section I.

That Appendix A, Section 11.100, Subsection (1), (A) and (B) of the code of

ordinances of the City of Orange, Texas be and is hereby amended to read as follows:

- (1) The following metered rate for water measured through a single meter, in increments of one thousand (1,000) gallons shall be effective:
 - (A) <u>Residential and Apartment, Multi Unit and Commercial Customers</u>

(B) Volume charge shall be One Dollar and Eighty Cents (\$1.80) for each 1,000 gallons in excess of the minimum bill.

Section II.

It is expressly ordained that if any section or subsection, clause, sentence or paragraph

of the ordinance shall be found to be illegal, invalid or void by any court of competent jurisdiction,

then such findings shall not affect the remaining portions of this ordinance, but the same shall be

That the rates in this ordinance will go into effect for the first billing cycle in October,

2005.

AN ORDINANCE AMENDING CERTAIN PORTIONS OF APPENDIX A, SECTION 11.200, OF THE CODE OF ORDINANCES OF THE CITY OF ORANGE, TEXAS PERTAINING TO UTILITY SERVICE RATES AND CHARGES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ORANGE,

TEXAS:

Section I.

That Appendix A, Section 11.200, Subsection (2), (A) and (B) of the code of

ordinances of the City of Orange, Texas be and is hereby amended to read as follows:

- (2) <u>Rates</u>
 - (A) Class A Users

Monthly bill = \$9.50 + \$6.20 per 1,000 gallons (or increment) of usage over 1,000 gallons.

(B) Class B Users

Monthly bill = 9.50 + 6.20 per 1,000 gallons of usage over 1,000 gallons.

In addition to the monthly rates as established the City may charge a surcharge for excess BOD, TSS, or other pollutants as needed. Such surcharges would be established and approved as needed.

Section II.

It is expressly ordained that if any section or subsection, clause, sentence or paragraph of the ordinance shall be found to be illegal, invalid or void by any court of competent jurisdiction, then such findings shall not affect the remaining portions of this ordinance, but the same shall be valid and in effect, it being the expressed intention of the City Council of the City of Orange, Texas to pass each and every sentence, clause, paragraph or section individually.

E. Long-Term Debt

General Obligation Bonds/Certificates of Obligation

The government issues general obligation bonds and certificates of obligation to provide funds for the acquisition and construction of major capital facilities. General obligation bonds, certificates of obligation and tax notes have been issued for both governmental and business-type activities. The original amount of general obligation bonds and certificates of obligation issued in prior years was \$22,460,000. During fiscal year 2005 the City issued two issues (1) the General Obligation Refunding Bonds Series 2005 and (2) Tax Notes Series 2005.

On July 13, 2005 the City of Orange issued the Series 2005 General Obligation Refunding Bonds of \$4,360,000 (par value) with interest rates of 3% - 4% to advance refund a portion of the Series 1999 General Obligation Bonds with interest rates of 5% - 5.5% and a par value of \$4,050,000. The Series 1999 General Obligation Bonds mature on August 1, 2019 and are callable on August 1, 2009. The Series 2005 General Obligation Refunding Bonds were issued at par and after paying issuance cost of \$111,344, the net proceeds were \$4,268,628. The net proceeds from the issuance of the Bonds and \$107,525 of accumulated City interest and sinking contributions were used to purchase US Securities and those securities were deposited in an irrevocable trust with an escrow agent to provide debt service payments until the Series 1999 Bonds are called on August 1, 2009. The advance refunding met the requirements of an in-substance debt defeasance and the portion of the Series 1999 Bonds that were refunded were removed from the City's government-wide financial statements. As a result of the advance refunding, the City reduced its total debt service requirements by \$196,574, which resulted in an economic gain (difference between the present value of the debt service payments on the old and new debt) of \$14,522.

On August 1, 2005 the City of Orange issued the Series 2005 Tax Notes with a par value of \$1,560,000. The bonds have a interest rates of 3.25%-3.75%. The tax notes were issued as seven (7) year serial notes with a final maturity of February 1, 2012.

General obligation, certificates of obligation, and tax notes are direct obligations and pledge the full faith and credit of the government. General obligation bonds and certificates of obligation generally are issued as twenty (20) year serial bonds with varying amounts of principal maturing each year. It is the intent of the City to pay for General Obligation bonds and Certificates of Obligation issued for business-type activities out of the revenues of the activity. General obligation bonds, certificates of obligation and tax notes currently outstanding are as follows:

(2) Amending Applicant's certificate would result in the Applicant's ability to furnish water and sewer services in the proximate area. Because the quality of Applicant's services are higher, the cost of Applicant's services lower, and the reliability of Applicant's services greater, the consumers in the areas will be presented with a choice, and the likely effect will be that consumers will elect to receive services from Applicant rather than continue receiving inferior services from the current providers. If the decertifications sought are granted, then the current providers will no longer be certificated and will not able to operate in the respective areas at issue.

In this regard, the Applicant has made numerous efforts to come to an agreement with Aqua Texas, the provider for one of the annexed areas, to acquire its current system for fair market value, but provider Aqua Texas has consistently refused to negotiate in good faith, instead making unreasonable demands. As the Applicant is required by law to provide comparable services in an annexed area when a current provider's services are inferior, the Applicant now seeks decertification of current provider Aqua Texas, which is one of three retail public utilities serving the proximate area.

The other two retail public utilities for which decertification is sought are (a) North Orange Water and Sewer and (b) Kelly Brewer. As with provider Aqua Texas, Applicant previously initiated negotiations to acquire the systems of these respective utilities for fair market value. Unlike Aqua Texas, the negotiations with provider North Orange Water and Sewer and with provider Kelly Brewer are mutual and remain ongoing. As such acquisitions have not been completed by mutual agreement as of this date, however, Applicant must simultaneously move forward with this Application and Addendum for the decertification of all current providers, regardless of system acquisition status, in order to comply with the requirements imposed on it by Texas law.







Utility details for MAURICEV







> As stated in the base application, the circumstances driving the provision of service in the areas at issue are based on the fact that such service is mandated by Section 43.056(g) of the Texas Local Government Code as a result of Applicant's annexation of the area at issue. Specifically, the Applicant, as the annexing entity of the area at issue, is obligated to provide a level of services in the annexed areas that is comparable to the level of services provided in other parts of the municipality serviced by Applicant. See Tex. Loc. Gov't Code 43.056(g).

> In this regard, the services provided by the current providers in the areas at issue are not comparable to the level of services provided by the Applicant in other areas of the municipality. Namely, the line sizes of the current providers are far smaller than those available to customers in the other parts of Applicant's service area, and there is a lack of fire hydrants. Further, the quality of water of the current providers is inferior, while the current providers' respective rate structures are higher, both of which highlight the lack of comparability between services in the area at issue and the greater area serviced by Applicant. Finally, the service of the providers is not comparable with that of the Applicant with regard to reliability and stability. - (1) The effect of the granting of an amendment to Applicant hereunder would be to allow Applicant to comply with the statutory mandate that it must satisfy under the Municipal Annexation Act of the Texas Local Government Code by authorizing it to operate in the annexed areas so that it may provide the comparable level of services it is mandated to provide to the areas at issue as annexed areas. In the absence of an amendment to its CCN, the Applicant will not be able to the provide the comparable services that it is mandated to provide under the Texas Local Government Code, which will seemingly create a conflict between the operation of the Municipal Annexation Act and the Texas Water Code.
- (2) Amending Applicant's certificate would result in the Applicant's ability to furnish water and sewer services in the proximate area. Because the quality of Applicant's services are higher, the cost of Applicant's services lower, and the reliability of Applicant's services greater, the consumers in the areas will be presented with a choice, and the likely effect will be that consumers will elect to receive services from Applicant rather than continue receiving inferior services from the current providers. If the decertifications sought are granted, then the current providers will no longer be certificated and will not able to operate in the respective areas at issue.


