House Bill 2876 was enacted during the 79<sup>th</sup> Regular Session of the 2005 Texas Legislature. The enactment of this Bill changed the criteria in Chapter 13 of the *Texas Water Code* to consider when granting or amending CCN certificates. On December 14, 2005, the Texas Commission on Environmental Quality also adopted changes to Chapter 30, *Texas Administrative Code*, Subsection 291, to require additional criteria be considered when granting or amending CCN certificates. The outline below is designed to help us capture the information required to meet the new criteria in accordance with the new statutes and rules. The Commission also reserves the right to request additional information if necessary.

- I. Demonstrate the Need for Service by providing the following: (See Addendum I:A/B)
- A. Describe the service area and circumstances driving the need for service in the requested area. Indicate the name(s) and address(es) of landowner(s), prospective landowner(s), tenant(s) or resident(s) that have requested service; and/or
  - B. Describe the economic need(s) for service in the requested area (i.e. plat approvals, recent annexation(s) or annexation request(s), building permits, septic tank permits, hospitals, etc.); and/or
  - C. Discuss in detail the environmental need(s) for service in the requested area (i.e. failing septic tanks in the requested area, failing wells, etc.); and/or
  - D. Provide copies of any written applications or requests for service in the requested area; and/or
  - E. Provide copies of any reports and/or market studies demonstrating existing or anticipated growth in the requested area. (See Addendum I:E)

II. Effect of Granting of a Certificate of Amendment: (See Addendum II:A)

- A. Explain in detail the effect of the granting of a certificate or an amendment, including, but not limited to regionalization, compliance and economic effects on the following:

*As stated in the base application, the circumstances driving the provision of service in the areas at issue are based on the fact that such service is mandated by Section 43.056(g) of the Texas Local Government Code as a result of Applicant's annexation of the area at issue. Specifically, the Applicant, as the annexing entity of the area at issue, is obligated to provide a level of services in the annexed areas that is comparable to the level of services provided in other parts of the municipality serviced by Applicant. See Tex. Loc. Gov't Code 43.056(g).*

*In this regard, the services provided by the current providers in the areas at issue are not comparable to the level of services provided by the Applicant in other areas of the municipality. Namely, the line sizes of the current providers are far smaller than those available to customers in the other parts of Applicant's service area, and there is a lack of fire hydrants. Further, the quality of water of the current providers is inferior, while the current providers' respective rate structures are higher, both of which highlight the lack of comparability between services in the area at issue and the greater area serviced by Applicant. Finally, the service of the providers is not comparable with that of the Applicant with regard to reliability and stability. Thus, the economic need for lower costs together with the mandate of the applicable annexation statutes for the provision of comparable services by the annexing municipality underscore the circumstances presented and the Applicant's request herein.*

**AREA II**

Size - Area II encompasses approximately 221 acres of mostly developed land. (See Area II Map, Appendix A.3.)

Location - The S.R.A. Canal to the west, the Entergy Highline R.O.W. to the north, SH 87 to the east, and Area III to the south bound the area.

Land Type - Area II includes nine subdivisions, Chasse Gardens, Chasse Ridge Estates, Chasse Ridge, Steeple Chasse Drive, West Chasse, Bear Trails, Chasse Hollow, Cub Trail, and Bear Path. Houses in the Steeple Chasse and Bear Trails subdivisions are mostly single story houses of varying construction and age. Houses in the Chasse Hollow, Cub Trail, and Bear Path subdivisions are of varying age and construction. However, the houses in the remaining four subdivisions are mostly medium to large newer homes, one and two-story brick construction.

Population - The projected future population for Area II is 733 people. This includes an estimated existing population of 563 plus 170 people for the undeveloped land within Area II.

**AREA III**

Size - Area III encompasses approximately 387 acres of developed and undeveloped land. (See Area III Map, Appendix A.4.)

Location - The S.R.A. Canal to the west, Area II to the north, SH 87 to the east, and FM 3247 to the south bound the area.

Land Type - Area III contains four subdivisions, Tally-Ho and Hi-Ho Acres subdivisions west of FM 1130, and Little Cypress and Woodlawn subdivisions east of FM 1130. The

houses in Area III are generally older one-story houses of varying construction. In addition, there is approximately 83 acres of undeveloped land west of FM 1130, bordering FM 3247 and the Little Cypress Junior High School (LCJHS) campus. The LCJHS will not be included as part of this report as it already receives services from the City of Orange.

Population - The projected future population for Area III is 715 people. This includes an estimated existing population of 318 plus 397 people for the undeveloped land within Area III.

**AREA IV**

Size - Area IV encompasses approximately 343 acres of mostly developed residential land. (See Area VI Map, Appendix A.5.)

Location - SH 87 to the west, a projection of Bear Path Road and the north line of the Cypress Bayou Estates Phase III subdivision to the north, the Union Pacific Spur on the East, and the Union Pacific railroad on the South bound Area IV.

Land Type - Area IV contains three existing subdivisions, Cypress Bayou Estates Phase I, II and III. The houses are mostly one-story structures of varying construction and age. There is approximately 24 acres of undeveloped land in the southeast section of Area IV.

Population - The projected future population for Area VI is 923 people. This includes an estimated existing population of 730 plus 193 people for the undeveloped land within Area IV.

- (1) *The effect of the granting of an amendment to Applicant hereunder would be to allow Applicant to comply with the statutory mandate that it must satisfy under the Municipal Annexation Act of the Texas Local Government Code by authorizing it to operate in the annexed areas so that it may provide the comparable level of services it is mandated to provide to the areas at issue as annexed areas. In the absence of an amendment to its CCN, the Applicant will not be able to provide the comparable services that it is mandated to provide under the Texas Local Government Code, which will seemingly create a conflict between the operation of the Municipal Annexation Act and the Texas Water Code.*
- (2) *Amending Applicant's certificate would result in the Applicant's ability to furnish water and sewer services in the proximate area. Because the quality of Applicant's services are higher, the cost of Applicant's services lower, and the reliability of Applicant's services greater, the consumers in the areas will be presented with a choice, and the likely effect will be that consumers will elect to receive services from Applicant rather than continue receiving inferior services from the current providers. If the decertifications sought are granted, then the current providers will no longer be certificated and will not be able to operate in the respective areas at issue.*

*In this regard, the Applicant has made numerous efforts to come to an agreement with Aqua Texas, the provider for one of the annexed areas, to acquire its current system for fair market value, but provider Aqua Texas has consistently refused to negotiate in good faith, instead making unreasonable demands. As the Applicant is required by law to provide comparable services in an annexed area when a current provider's services are inferior, the Applicant now seeks decertification of current provider Aqua Texas, which is one of three retail public utilities serving the proximate area.*

*The other two retail public utilities for which decertification is sought are (a) North Orange Water and Sewer and (b) Kelly Brewer. As with provider Aqua Texas, Applicant previously initiated negotiations to acquire the systems of these respective utilities for fair market value. Unlike Aqua Texas, the negotiations with provider North Orange Water and Sewer and with provider Kelly Brewer are mutual and remain ongoing. As such acquisitions have not been completed by mutual agreement as of this date, however, Applicant must simultaneously move forward with this Application and Addendum for*

*the decertification of all current providers, regardless of system acquisition status, in order to comply with the requirements imposed on it by Texas law.*

*(3) The effect of amending Applicant's CCN on landowners in the areas at issue would be to benefit the landowners by putting in place a system for better services (higher quality, more reliable, etc.) at a lower cost. Thus, the economic impact would be beneficial to the landowners, who would pay lower costs for higher quality services, and the quality and reliability of the services, together with improved fire protection, will benefit the landowners in the areas as well. Moreover, the expectations of the landowners would be validated, since they expect an improvement in services as a result of the annexation by the applicant of the areas at issue.*
