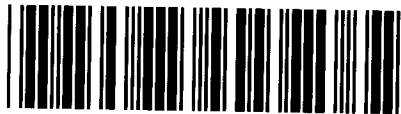



H.B. 3674 transformed Section 132.001 of the Civil Practice and Remedies Code – a little-known provision dealing solely with the use of unsworn declarations by inmates (since they have limited access to notaries) – into a provision with very broad potential implications. As passed, the amended provision allows the use of an unsworn written declaration made under penalty of perjury in lieu of a written sworn declaration, verification, certification, oath, or affidavit required by statute or required by a rule, order, or requirement adopted as provided by law. (The section does not apply to an oath of office or an oath required to be taken before a specified official other than a notary.) The new law is effective September 1, 2011.

UTILITY SERVICE IN BOWIE  
COUNTY, TEXAS

City of DeKalb filed an ap-  
plication to amend CCN No.  
10542 and to obtain dual  
certification with a portion of  
Central Bowie County WSC,  
CCN No. 10525 with the  
Public Utility Commission of  
Texas to provide water utility  
service in Bowie County.  
The proposed service area is  
located approximately 1.0 mile  
west of downtown DeKalb, Tex-  
as, and is generally bounded on  
the north by SW Front St., on the  
east by Rutherford St., on the  
south by 1 mile north of East  
Elliot Ln; and on the west by US  
259.

The total area being requested  
includes approximately 64 acres  
and 0 current customers.  
The proposed amendment af-  
fects customers and/or areas  
located in the following zip code:  
75559.

A request for public hearing  
must be in writing. You must  
state (1) your name, mailing  
address, and daytime tele-  
phone number; (2) the ap-  
plicant's name, application  
number or another recogniz-  
able reference to this ap-  
plication; (3) the statement, "I/  
we request a public hearing";

(4) a brief description of how  
you or the persons you re-  
present, would be adversely af-  
fected by the granting of the  
application for a CCN; and (5)  
your proposed adjustment to  
the application or CCN which  
would satisfy your concerns  
and cause you to withdraw  
your request for a hearing.

Persons who wish to inter-  
vene or comment should

within thirty (30) days from  
the date of this publication  
or notice. A public hearing  
will be held only if a legally  
sufficient hearing request is  
received or if the Commission  
on its own motion requests a  
hearing. Only those individ-  
uals who submit a written  
hearing request or a written  
request to be notified if a  
hearing is set will receive no-  
tice if a hearing is schedu-  
led. If a public hearing is request-  
ed, the Commission will not  
issue the CCN and will for-  
ward the application to the  
State Office of Administra-  
tive Hearings (SOAH) for a  
hearing. If no settlement is  
reached and an evidentiary

submit a recommendation to  
the Commission for final de-  
cision. If an evidentiary hear-  
ing is held, it will be a legal  
proceeding similar to a civil  
trial in state district court.

If you are a landowner with a  
tract of land at least 25 acres  
or more, that is partially or  
wholly located within the pro-  
posed area, you may request  
to be excluded from the pro-  
posed area (or "opt out") by  
providing written notice to  
the Commission within (30)  
days from the date that no-  
tice was provided by the ap-  
plicant. All request to opt out  
of the requested service area  
must include a scaled, general  
location map and a metes  
and bounds description of the  
tract of land.

Persons who meet the re-  
quirements to opt out, and  
wish to request this option  
should file the required docu-
