COMMISSION STAFF'S SECOND RECOMMENDATION ON SUFFICIENCY

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Commission Staff's Second Recommendation on Sufficiency and would show the following:

I. BACKGROUND

On January 16, 2015, City of DeKalb (DeKalb) filed with the Commission an application (Application) to amend its water certificate of convenience (CCN) in Bowie County, Texas pursuant to Tex. Water Code Ann. §§ 13.242-50 and Title 16, Tex. Admin. Code (16 TAC) §§ 24.101-07. DeKalb seeks to amend its CCN to extend its service area as a result of the need for water service in the proposed area. In Order No. 2, the Administrative Law Judge (ALJ) deemed the Application insufficient and gave DeKalb until March 18, 2015 to amend its notice and allowed Staff until April 17, 2015 to file a supplemental recommendation. On March 6, 2015 DeKalb filed supplemental information. Therefore, this pleading is timely filed.

II. RECOMMENDATION ON SUFFICIENCY

As detailed in the attached memorandum of Leila Guerrero (Attachment A) of the Water Utilities Division, Staff recommends that the Application and proposed notice be deemed

sufficient. Attachment A also contains some instructions on providing notice. Attachment B is draft sample notices, and Attachment C is Affidavit of Notice forms.

III.PROPOSED PROCEDURAL SCHEDULE

Deadline for DeKalb to submit affidavits of	June 10, 2015

Deadline to intervene, file comments, or	30 days after notice is issued
request a hearing	
Deadline for Staff to file recommendation,	July 20, 2015
request for hearing, and/or an additional

Staff notes that customers have the ability to opt out of a CCN request.² In the event customers wish to opt out of the CCN, additional procedures may be needed before Staff may make a recommendation. Additionally, in the event Staff were to recommend final approval of the CCN amendment, Staff's ability to meet the above deadline is driven in part by Staff's receipt of consent to final mapping from Applicant. Therefore, Staff's proposed procedural schedule allows Staff the opportunity to either file a recommendation after the customer comment period or recommend an additional procedural schedule.

IV. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above recommendations.

¹ After Staff receives the affidavits of notice and the comment period has elapsed, Staff will be able to recommend other procedural deadlines appropriately.

On January 16, 2015, the City of DeKalb (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10524 and to obtain dual certification with a portion of Central Bowie County WSC, CCN No. 10525, in Bowie County, Texas. This application is being reviewed pursuant to the criteria in the Texas Water Code, Chapter 13 and the PUC's Substantive Rules in Chapter, §§24.102 – 24.107.

On March 6, 2015, staff received new maps, mapping data and hard copy maps submitted by the Applicant and was reviewed by staff.

Based on Staff's review of the information in the application and the new mapping information, Staff recommends that the application be deemed sufficient for filing. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide correct notice of the application to the following:
 - a) any districts, groundwater conservation districts, counties, utilities, cities, cities with an extraterritorial jurisdiction within two (2) miles of the proposed service area;
 - b) any city with an extraterritorial jurisdiction which overlaps the proposed service area;
 - c) landowners with more than 25 acres and any affected parties in the proposed CCN area. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN lies; and
 - d) notice to the public which must be published once each week for two (2) consecutive weeks in a newspaper of general circulation in Bowie County;

- 2) Include a copy of a map showing the proposed service area with the individual notices to neighboring utilities, other affected parties and each landowner. It is the Applicant's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at http://www14.tceq.texas.gov/iwud/.
- 3) Notify **Sulphur River Basin Authority**, **Red River Authority of Texas and Bowie County** in addition to the neighboring entities listed in the application.
- 4) Return a copy of the actual notice sent with attached signed affidavit indicating that the notice was given by June 10, 2015.

If a public hearing is requested, the Commission will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the proposed area, you may request to be excluded from the proposed area (or "opt out") by providing written notice to the Commission within (30) days from the date that notice was provided by the applicant.
