



ORDER NO. 3 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On January 16, 2015, the City of DeKalb (DeKalb or the City) filed with the Public Utility Commission of Texas (Commission) an application to amend its water certificate of convenience (CCN) in Bowie County, Texas. The City requests the addition of 64 acres to its certificated water service area and dual-certification with Central Bowie County Water Supply Corporation in this area.

II. Commission Staff Recommendation on Administrative Completeness

On April 16, 2015, Commission Staff filed comments on the sufficiency of the application and notice. Commission Staff recommends that the City's application be deemed sufficient for further review and its notice be deemed sufficient. Consistent with Commission Staff's recommendation, the City's application is deemed administratively complete.

III. Commission Staff Recommendation on Notice

Commission Staff has reviewed the City's proposed notice with regard to applicable statutes and rules. Consistent with Commission Staff's recommendation, the City shall provide notice, including proof of notice, using the forms and according to the instructions provided in Commission Staff's April 16, 2015 filing.

IV. Procedural Schedule

Commission Staff proposed a procedural schedule. Consistent with Commission Staff's recommendation, the following procedural schedule is adopted:

Event	Date
Deadline for DeKalb to submit affidavits of notice	June 10, 2015
Deadline to intervene, file comments, or request a hearing	30 days after notice is issued
Deadline for Staff's final recommendation, request for a hearing, and/or an additional procedural schedule.	July 20, 2015

V. Filings

Parties are reminded that an original and ten copies of documents relating to this proceeding must be filed with the Commission filing clerk according to P.U.C. PROC. R. 22.71. A copy of each document filed with the Commission must also be served on all parties.

VI. Communications

Parties are also reminded that direct communications with the administrative law judges and presiding officer (collectively, ALJs) are prohibited. Questions concerning this order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
