COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Request for Extension, and would show the following:

I. BACKGROUND

On January 26, 2015, Gonzales County Water Supply Corporation (Gonzales County WSC) and the City of Gonzales (collectively, Applicants) filed an application, pursuant to TEX. WATER CODE §13.248, for approval of an agreement to decertify and transfer a certain 138.62 acre tract of land located within Gonzales County WSC's certificated area. On September 29, 2015, the Order No. 7 was issued, which extended the procedural schedule deadlines, and set November 9, 2015 as the deadline for Staff's recommendation or request for a hearing on the merits.

II. REQUEST FOR EXTENSION

Staff has developed the final maps in this proceeding and submitted them to Gonzales County WSC and the City of Gonzales for their consent. However, Staff has not received the consent documents from all the parties. Staff is not able to issue its final recommendation until it can certify that the parties are in agreement with the service area transfer. Staff requests additional time to receive the consent documents needed to finalize Staff's recommendation. Staff recommends the following procedural schedule:


